The bear harvest has already been on an increase the past several years, with depredation decreasing each year. Deer units on a predator management plan should have to show proof that bears are the reason or a substantial part of the reason the unit is below objective before we increase tags. Humans are the deers biggest predator and tags should be decreased for deer and keep the human predator in check for harvest. Much of the state is not having an increase in bear numbers and units such as the Bookcliffs are seeing less bears and this is from a person who has hunted the Bookcliffs for over 3 decades.

Please do not make these changes that aim to increase the harvest of bears in Utah. These simple solutions to complex problems seem ignorant to the importance of all trophic levels in our ecosystems. Carnivores are vitally important for keeping balance in Utah's ecosystems, and simply killing bears to save deer will result in a cascade of unintended ecological consequences, just as it always has throughout wildlife "management" history in the American West. You don't save wildlife by decimating wildlife. Mule deer population decline is multi-factorial; loss of habitat, less available nutrition, and Chronic Wasting Disease (CWD) are significant contributors to their decline. Harvesting more bears to alleviate this problem is a short-sighted solution to temporarily boost deer populations. This "top-down" approach neglects to address the fact that natural carnivores reduce the spread of CWD. A "bottom-up" strategy will have a better long-term outcome and could include reducing livestock densities to allow for more nutrition availability for cervids. Fighting to maintain or increase habitat will surely help mule deer and entire wild communities in Utah.

The predator management program is leading to an anti-sportsmans decisioning process. The complete slaughtering attempts of cougars currently in action on the Manti (previously 4 units) is an example. There are inconsistencies coming from the Division's biologists in deer management. Covey made it clear that he does not want more deer on the Manti due to CWD but we're attempting to eliminate cougars from the land scape and now attempting to lump bears into a risky plan as well in the name of more deer.
