- Buck deer tag adjustments seem to be ok, in general. However, the Pine Valley seems a little steep on the decline and Cache seems a little aggressive on the increase. Additionally, for the units that made a 1 year jump increase in Buck to Doe ratios (though the previous 2 years were down), I think it's unwise to make a knee jerk reaction for permit increases. Populations are still under objective, so that makes no sense to me, especially when the 3 year average is still within the objective range set for the unit.
- Late season, limited entry muzzleloader permit increases on the Central Mountains Manti seems excessive with an over 50% increase (25 to 39). We don't have to shoot them all up, just because we can!
- Myton CWD buck deer removal is not a good idea. The science is so conflicting and has not been proven to remove CWD long term.

You say the population last year was 300 which i find hard to believe spending almost 5 weeks in the area hunting moose, & elk, I was there throughout Sep- Nov. The elk herd has been wiped out over the last 5years. Your report says last year the population was 300 and 1 year later jumped to 750. Did you relocate elk from another area? Or did the cow elk all have 3 calves each? This area is probably the most hunted area for elk in Utah on opening day of rifle hunt and people are chasing ghost. You need to increase the objective for this area not decrease. We hunt with a camp of avg. 15 hunters for elk in this area each year we use to fill 3 to 5 tags a year, we got 1 spike bull last year and 0 the previous 2 years so i look at we are 1 out 45. I have hunted this area since I was 14yr old & now am 45yrs old and this is the worst i have ever seen it. Pease consider increasing the objective population for this area instead of decreasing for my 3 boys that just started hunting sake. As a former Utah resident I have always and will always have an genuine interest in Utah's wildlife. I'd like to propose that as a partial solution to the depredation issues, that a pool be created for disabled youth/individuals or even women and children in general where if there is a depredation issue, the landowner can call into the DWR and a voucher/tag from the landowner be given to one of these individuals in the pool to go out and have an opportunity to remove an animal causing the depredation. This would increase opportunity for those individuals in more friendly terrain in a lot of cases while also creating a more immediate response to depredation. I agree with the presentations and discussions in the RACs while also realizing that if deer are going to die of drought or other similar causes they might as well be hunted. I realize that monsoonal rains or something that might benefit deer going into the winter and new year and are difficult to forecast when adjusting permit numbers at the beginning of the year. I would like to propose a separate tag pool where sportsmen and women elect to either have their tag removed or be given a tag if the conditions would be better for the health of the deer herd. Maybe that's a simple button on the application process where you can select to be an alternate if you're unsuccessful in the draw or if you do draw, and it would be better for the deer herd to take fewer animals to keep the population from swinging too much in the coming year, then the DWR can ask those volunteers to return the tag.

Some of these thoughts might be better geared towards the elk committee. but some of them are surrounding trophy units, specifically the immediate need surrounding the Beaver unit. I understand that the age class is a surrogate for bull quality as described by Covy in multiple board and RAC meetings. My concern is that as we try to maintain certain age classes that it becomes difficult to manage the herd. Similar to what happened in the Beaver unit where there is now nearly a 1:1 bull:cow ratio. I understand this came partly because we needed to remove lots of cows and were over population objective. This has led to an unhealthy herd ratio while many bulls that otherwise would be available to the public to take are now likely to die from natural causes without a permit increase for bulls. Although we have a desire for quality bulls, this takes away from more opportunity from the public to hunt and creates more of a burden on the point creep than already exists. I feel that the Beaver Unit may just be the first casualty to the age class system with other units likely to follow. I'd like to see an increase of permits and increase of opportunity for the public to alleviate the burden on the point creep. I support the Southern RAC's proposal to increase the number of tags on the Beaver Unit. Bulls eat a significant amount of feed more than cows and calves. Reducing the number of bulls would allow for larger elk herds in a healthy manner and create more opportunity even in the antlerless elk hunts which I fondly grew up hunting. I recently moved from Utah to Wyoming and see that they manage their elk herds with a bull:cow ratio, similar to what Utah does with its deer. I'm not a biologist, but to me it would seem that you could more closely manage a healthy herd that way while also providing more opportunity to the public while having a more useable reference point (bull:cow) ratio rather than the age class. A bull:cow ratio could be broken down to know how many mature bulls:cows and so on. This would still allow for those trophy units to have trophy animals by simply managing the number of bulls (30-40 bulls:100cows in trophy or 20-30:100 in more opportunity based units) rather than being restricted by age class.

My biggest concern is the bookcliffs elk herd. Now seeing the age class drop seems like a bad deal. I participated in an elk hunt there last year, and there just wasn't allot of feed out there. The summer rains did come last year but with the cows, wild horses, Buffalo, etc.. it seems like there are too many mouths out there. I feel like we need a lot better management of the wild (feral) horses and cows by the BLM and state.

We went out to steer ridge where I shot a nice bull 15 years ago and at that time we saw lots of elk. Last year we only saw one elk, there was hardly any feed even though all the stock ponds were full and we saw probably over 50 Feral horses.

Also let's reduce the pressure on the elk either by eliminating the spike hunt or at the minimum keeping it a 5 day hunt or finding more sanctuaries out there by closing roads. Thanks for your time just a few ideas.

I'm just not a fan of the spike hunt. The spike hunt might have worked in years past but when we have drought years it seems like we need to just be nimble and eliminate that hunt. It seems like more drastic measures are needed.

I heard Dax (division) from the NE RAC talk about years hunters should hunt the spike hunt. He suggested hunters should hunt out there years were there was good calf survival the previous year and a half. Then not hunt out there when there was poor survival. So why not take it further and either eliminate spike hunting when the division saw poor calf or pregnancy rates from the previous 1.5 year. Whatever the species, I have the same input. I never see nor hear addressed a phenomena that has had a huge impact on our state's hunting: the guide industry. Sometimes we seem to forget that the wild game on public land, as with the land itself belongs to the public. Us. Every citizen. The resources that are there are thus protected by governing entities. If I were to have a business that utilized public resources for personal or corporate financial gain, and thereby extracted the choicest examples of that resource, to sell, there should be a public outcry. If I had the financial resources to hire or entice by bounty, others to detect that unique specimen and give me it's location so that I could thereby gain by utilizing that information to gain thousands of dollars by taking a client to harvest it, I would be taking something that belongs to everyone and profiting from it. Unfairly, I might add. In my area, some guides offer large sums of money for photos and coordinates of trophy animals. They then keep track of the same. I have, on numerous occasions, witnessed roads being completely blocked on opening morning by as many as a dozen vehicles, on every access to an area (guides and spotters) because of a trophy animal being there. This I have witnessed numerous times. (I used to work for the US Forest Service. ) I knew the guides and the people that worked for them. Many of them were my friends. But it is sure just not right. Everyone should have the expectation that they have an equal chance, if they put in the work, to harvest a great animal, and these marvelous creatures should not have a tag hanging from their ear that reads: killed by the guy that could afford someone to tie it up for him.

- I would like the Pine Valley and Zion late muzzy tags reduced by one. It appears that because the 0.5% tag allocation for those tags did not fall on a whole number they rounded up. With those deer units struggling like they are those late tags need to be rounded down do they don't go above the 0.5% tag allocation that set.
- I would like if the board could ask the division why they didn't increase premium tags on the Henrys and the Paunsaugunt and if it is justified I would recommend that the board consider increasing the Paunsaugunt and Henry premium tags by 2-3 tags. With the 3 year average age coming in at around 25% higher then the objective I think we can increase those tags slightly and offer a little more opportunity. While I watch all the RAC meetings and the elk plan on everyone's mind it seemed like every one is interested in finding a way to increase tags and add opportunity where we can for that species. I hope we can take advantage of increasing deer tags also when we have the opportunity to do so.

I would like to address the movement of tags from archery and muzzloader hunts on the Wasatch elk unit.

I have watched the RAC committee presentations and have seen Covy's response to the issue. I see and understand why they did what they did. The only issue I have is that you are taking a large portion of tags that people assumed would be available for certain hunts and moving them. Many people watch the points needed to draw for units and apply for certain hunts based on those numbers. You guys are now proposing to shift a large portion of tags away from hunts that people were counting on being able to draw and making it less likely that they will draw.

I get that this is a social issue and am under the understanding that starting next year with the application process being later that people will be able to apply knowing what the proposed tag numbers will be. Also the Elk committee is meeting this year to make a new 7 year proposal that could address this issue as well.

Since the tag numbers on the Wasatch are remaining exactly the same I would like the Wildlife Board to consider keeping the tag allotments for archery and muzzloader on the Wasatch and any other units that are under similar circumstances the same as last year and to not increase tags on the mid, and late rifle seasons. Or at the very least maybe not make it such a drastic cut. The issue with tag allocations can be addressed next year with the Elk committee and the later application process that way the public is not blindsided by a tag cut for a hunt after they apply.

Thank you for taking the time to consider my suggestion, this is my second comment on this to you guys but now I have more clarification since Covy addressed it in a couple of the RAC meetings.
