Utah's nonresident fishing licenses first should be aligned with the cost of neighboring states' nonresident licensing. Utah's current and proposed nonresident fees are lower than Wyoming, Idaho, etc. It seems obvious that the first step would be to align nonresident fishing fees with the regional market, before putting any burden on residents. Only once Utah nonresident fees are equal to surrounding states should residents be expected to start addressing revenue burdens via resident fee increases. I don't hunt, but I would support also shifting all resident hunting fee increases over to nonresidents as well. \$0 increase for resident hunters. Put the burden on all of the tourist hunters, who as with the nonresident fishermen, likely are not going to base their decision much on the cost of the tag/license anyway.

The Northeastern RAC meeting inspired me with an idea I'd like you all to consider. I'll be archery hunting and will be unable to attend the meeting in person.

As a previous dedicated hunter, I was somewhat supportive of the idea of doubling the rate for buying out the hours because we really do have a problem with people doing that instead of actually volunteering their time (especially in some of the sought after southern units)

That said--especially the first year--it can be EXTREMELY difficult to find projects in such a small time frame. (You basically have 2 months to find a project and get your first 8 hours completed.)

That sounds like a lot of time, but when there are projects they fill up extremely fast because people procrastinate, which makes the demand very high.

I won't go into my idea about how to fix that, and I'll only speak to the fee structure for this meeting.

I propose that the fee be \$20/hr for the first 8 hours, and \$60/hr for the remainder... This allows people to get that first tag by buying the hours if necessary, and severely penalizes those who refuse to volunteer.

Getting the remaining hours is a walk in the park after that first season. (I did 36 hours in less than 2 months after the seasons were over, and I had more time to volunteer)

One other thing that also needs to be addressed here is credit for those buying materials for a specific project as well as the mileage per diem given on some projects. I believe those should also remain at \$20/hr. This does open a loophole for the people that want to just buy their way out, but at least they have to put in some effort to find the specific need, and purchase those materials.

Thank you for your good work on this. I know that raising fees as a public entity never tends to go well, but in general I do support actions that keep our wildlife management programs adequately funded.

There's only one item I'm having a really hard time with: I do not support a \$40 fee for a swan tag. I can't make sense of it no matter how I look at it.

Looking at other states, the most expensive resident swan tag is in Idaho for \$22.75. North Dakota and Nevada are \$10. Montana is \$5.

It also doesn't make sense when compared to other tag fees, such as a doe deer for \$33 or doe pronghorn for \$40. Those are more popular hunts with much more/better meat than a swan provides.

The only rationale I can find behind the \$40 amount is that the division wants to charge \$40 for a turkey and so they think they ought to charge \$40 for a swan as well. I disagree with this rationale for a few reasons: (1) the Division needs more revenue to manage turkeys than they do to manage swans. Turkeys need to be transplanted, cause depredation issues, etc. whereas swans just fly through habitat that we are already managing for ducks and geese. (2) A turkey hunt is a better and more popular hunt than the swan hunt. There were more than 11,000 applicants for LE turkey permits compared to just over 6,000 for swan. (3) Turkeys have more meat than a swan and the meat is much tastier. (4) The \$40 price point for turkey is already very steep, and it's not fair to use one steep fee to justify another. Resident turkey tags are \$22.75 in Idaho, \$20 in Nevada, and \$16 in Wyoming, as a few points of comparison.

I feel the same way about crane tags - \$40 is too much and makes no sense.

I would respectfully request a tag fee of \$20 for swans and cranes and to keep it at \$35 for turkeys. I think this would keep us more in line with other states and avoid a massive spike in prices that is hard to swallow, especially when everyone is already feeling stretched with inflation. I spend a lot of money on license/tags each year, but eventually there comes a straw that breaks the camel's back. I don't think I'll apply for swan or crane again if the fee is raised to \$40, and I'm sure others feel the same. I also think we will lose many if not most of our nonresident applicants for these species if the fee is increased from \$17 to \$125.

Thank you for taking on these hard decisions and attempting to do what's best for Utah's wildlife.
