Please manage bear populations for a quality opportunity vs the cougar type extirpation plan.

Propose 3-year waiting period for unfilled tags or tags filled with boars and a 6-year waiting period for tags filled with sows (could have exceptions for areas truly over population objective). That will have more effective sex selective influence than the current orientation course. Sex based quotas can also be effective and reduce guide pressure to shoot sows.
