We are tired of reduced tags and restricted hunt areas and never receiving the promised deer population growth, You continue to micro manage the hunters and seemingly ignore the status of the deer herd. Utah used to harvest as many bucks as we are now giving out tags for. This is a failure of epic proportions and a course correction is needed.

Your continued reduction of tags and reducing the size of the hunt areas shows your focus on buck to doe ratios and micro managing the hunters when you should be focused on what is killing the does and the fawns

The problem is the reducing number of does that are in the herd. The only way a herd can grow is if there are Does to be bred. You need to shift your focus off of the hunter and the buck to doe ratio and focus on what is killing the does. Take the resources currently used micromanaging the hunters and use it to figure out why the deer population isn't increasing.

There is something else restricting the deer population besides the weather and the buck deer hunters and you need to focus on the deer herd and find out what it is. For over 20 years you continue to blame the hunter (by reducing tags and hunt area) and the weather. It is time to admit your failure and make a course correction.

Buck deer hunting does not keep the population of deer from expanding yet your response to less deer is to cut buck tags and restrict hunt area size and ignore everything else. Ten years ago we hunters agreed to smaller hunt areas and reduced tags with the promise the deer herd would increase. The division has failed and the deer herd and the deer hunters are the ones who are paying the price of that failure.

However the data provided glossed over that in the 90's in southern Utah, one could drive a 10 mile stretch of mountain road and see several groups of deer with a quality buck (group of 5-10 does to 1 breeding buck) and likely a none breeding buck or two in the mix or in between herds. in the current times the same person can drive 20 miles and maybe see a deer. Need to look harder at what was done in the 80's to fix the mess we are in now. Just because some one wants to hunt doesn't mean they have to hunt. Do right for the herd, even if it restricts the DWR's pocket book and limits the number of hunters.

As a side note. the Hunt expo is BS. The DWR is making hunting a RICH PERSONS GAME and catering to the northern Utah/Out of state folks. Make it fair. Move it around the State and make everyone have a fair shake at applying. I have to pay \$70 dollars in fuel and spend a full day to sign up in person to apply. Although age and antler size are good indicators for the bull herd, Bull to cow ratios are critical for the total population. There needs to be a balance between grooming for quality animals and quantity of animals. The division is wrong in their approach and rational for the decline, drought and habitat are factors in the problem, but over issuance of cow tags, catering to the "cow boys" and and declining numbers of bull to cow ratio is the major contributors.

There is a very strong need to separate the Dutton, Boulder and Monroe units. Management of these quality units needs to occur at a summer/fall range usage. Most of these animals winter on the Dutton and get slaughtered in the cow hunts resulting in less yearling/two year old animals to sustain numbers for future. I have hunted elk on the Boulder for 20 years, I gave up cow hunting when it became harder than spike hunting due to low numbers (shortly after the Dutton and quota's for 1200 cows, the boulder at 600 cows).

This last spike season I observed 60 bulls, all 3 point or larger and 20 cows. NO SPIKES. 13 of the large bulls were sparing for rights to 6 cows. BULL TO COW NUMBERS MATTER, FIX IT!

Habitat matters as well, the "Cow Boys" don't care about any thing but making fat and padding pockets. Find a was to encourage them come to the table and support affirmative action! help improve the forage and support improvements for both. There is plenty of suitable land if it can be improved and maintained. Sure they may have to rest for a year or two, but in the long run they will have improved forage and possibly increased numbers. WELFARE RANCHING NEEDS TO BE CHECKED.

There is a super strong need to increase fuels reduction, understory management and control domestic grazing in efforts to reduce undesired wildfire effects on the landscape. Understory vegetation management and prescribed fires are the path forward to increasing habitat and increasing range capabilities for all ungulates.

The DWR can put the same effort into elk as deer, were are the studies, collars and tracking for elk similar to deer?
