On a unit you say is trending down you did not increase tags at all, but your just pulled tags from the hunts with lower success rates and gave them to hunts with much higher success rates.

While you may not have increased tags you did for sure just increase harvest on a population that you just admitted was trending down.

If your intentions was to increase harvest why are you pulling tags from the other hunts to do this??? Why not just slightly increase tags on the rifle hunts and add a few more tags, and leave the archery and muzzleloader hunts the same?

This tag reduction has large consequences to the people that put in for those hunts as it drastically reduces the chances of drawing for those hunts. Otherwise hunters who have counted on hunts based on previous numbers find out too late that they'll have no chance to draw, and too late to change the application to a unit where they'll have a chance to draw. What possible reason could there be to require a person to apply for something that might not even exist by the time the draw happens. It simply disadvantages the applicant, making it more difficult for them to be able to predict the odds for what they're applying. The draw is not until May, and it could be later. Make the application deadline after the permit numbers are known, and then do the draw right away, within 1-2 weeks.

I strongly disagree with the permit recommendations for the Beaver unit for the following reasons.

For the past decade we have watched the deer herd continue to decline on the Beaver unit. As a 4th generation hunter who also has property on the east side of the Beaver I can give you very specific reasons the permit numbers do not match the deer or buck population. I know a couple of the RAC members also live or hunt the Beaver and can agree with the same things I am seeing.

- 1. Deer numbers do not reflect the deer model number produced by DWR for the Beaver unit. I have watched the deer herd go from having 100's of deer in these fields to now being lucky to see any deer in these fields.
- 2. I drive over state highway 20 and down highway 89 often. I have watched it go from being an area you did not want to travel at night for fear of hitting a deer, to now never seeing a deer on the road.
- 3. I have witnessed seeing hundreds of deer during the hunts on the Beaver, to now rarely being able to show my grandson a buck, and very few deer in general.
- 4. I have been on the Beaver this past year during peak rut time. Monitored 6 different groups of doe that had about 8-10 doe in each group over about a 5 mile stretch of great winter/rutting grounds. Only 2 of these groups had a buck in with them. I watched this for about 4 weeks. Nothing changed. 4 groups of does never had a buck even in with them for the 4 weeks I was able to watch them.
- 5. I love to go out on the Beaver unit and look for sheds in the spring. I never find a deer shed anymore, yet years ago there was many sheds found in these same areas.
- 5. As a life long hunter on the Beaver unit, I have logged miles and miles on the ground each year. The steady decline in the numbers is so obvious that anyone that has been on the Beaver unit can admit it is in a tragic decline of deer numbers.

Some questions for us to Consider:

- 1. The Beaver unit is managed for 18-20 bucks per 100 doe which is stated by the statewide mule deer plan is to manage for a chance at older or larger bucks. With a average last winter of 14 Bucks per 100 doe, does this look like an objective that we are moving in the right direction?
- 2. Fawns born to late may not have time to grow large enough and build fat reserve to withstand the Utah winters according to DWR. With my findings of 4 groups of doe with no buck even in with them, is it a great possibility we do not have enough buck to cover the doe in the timeframe needed for fawn to be born earlier?
- 3. The Pine Valley unit managed for 18-20 Bucks per 100 doe shows an average of 19 Bucks per 100 doe but dropped one year down to 16. The tag numbers in the last two years are being cut from 4,500 to 1,700 which is a 62% cut over 2 years, yet the Beaver unit which also manages for 18-20 Bucks per 100 doe goes from 2,100 to 1,200 which is a 43% cut over

the same 2 years. Why is the Beaver not getting the same tag cut percentage as units like the Pinevalley when the Beaver unit is only showing 14 Bucks per 100 Doe?

4. From the presentation the DWR shows a graph that from 2016-2018 the Deer and buck numbers were very high, and also said in 2019 that we had more deer than ever before. Does the Beaver unit and other southern units pattern these statements?

What should happen.

- 1. Deer numbers on the Beaver are in far worse shape than the Pinevalley, yet only a 43% tag cut for the Beaver vs a 62% tag cut on the Pinevalley for the same period. To even get to an equal tag cut as the Pinevalley the Beaver would need to cut 1,300 tags over the past 2 years right now it will be 900 if the recommendation of 200 this year passes. More tags need to be cut to even have a chance of making a difference.
- 2. This meeting is about tag numbers, so I will stick with the agenda but ask the question of when does it get bad enough to shut units down to save a deer herd?

In Conclusion:

Each year I have tried to attend the RAC meetings and be a spokesman for the deer herds in southern Utah with the Beaver being my focus. This year I will be out of town but feel very passionate that you hear from someone who spends many many days and hours on the Beaver unit. From someone who has personally watched the deer herd go from one of the prized units in the state to the point of most likely no return. From someone who has two boys who I taught to love the Beaver unit, for the first time this year did not put in to hunt this unit. A place we ran cattle on, love to camp on, hike on and used to love to hunt on, but is now in dire need of some help.

Each year we hear the tag allocations come out and it is said that they feel the tag cuts will fit right into the objectives. I am asking you, especially you that live and hunt the Beaver, Do you see the tag cuts in the past turning our deer numbers around. In listening to the presentation it was stated that last year there were pretty significant cuts in the state and that they have worked. Areas that were falling are now trending up. This is just not happening on the Beaver as it will need an significant effort and cut like the Pinevalley to even give it a chance of recovery.

As one who is giving you years of knowledge and time on the Beaver unit, I hope you will consider more attention in tag cuts and whatever else can be done to help this unit NOW.

I appreciate all the data the division has brought forth and made that data more transparent. Just a few things I would like the RAC to talk about and address. The Henrys Premium hunt is trending up fast on the age objective almost double it objective at 74% >5 year old bucks. I feel like that number is high enough that we should be offering a small increase in tag numbers for that hunt. Also the Paunsaugunt Premium hunt although it has trended down slightly that is another hunt the RAC should consider a very small tag increase on my 1 or 2 tags.

On the some of the late season muzzy hunts it appears that some of them have been over allocated above the .5%. due to that number not landing as a whole number and then was rounded up. I would ask the RAC to look at those units and adjust those tags to round down so it doesn't go over the .5% max allocation.

Pine valley .5%= 8.5 should be 8tags. Proposed at 9 tags. Zion .5%=11.625 should be 11 tags. Proposed 12 tags.
