If you're going to up tags then cut hunt dates down to fewer days allowed in the field or do a 3 point or better system this year. Most hunters realize that managing game herds is costly endeavor, why not keep the cuts in the north and leave the south alone for one more year. Raise resident tag prices 10 percent and nonresident 20 percent for 2023 to offset the revenue loss. The bucks were a spike and a two point. There seem to be NO deer in the fields in Panguitch, Parowan, Summit, Hatch, and other surrounding communities this winter. I cannot imagine INCREASING the permit numbers in these units when decreasing them in Northern Utah. My vote would be to end the General Season Deer Hunt in Utah for two years. I know the DWR will get all upset & think they will have to let staff go. I would even pay for an (unused) tag in those years as an investment in the future of mule deer hunting in Utah. For those of us who have purchased a Garmin Xero when it is perfectly legal to use to hunt with, have made large investments on these bow sites. I think there should be a buyback to compensate us for the equipment we purchased for hunting when it was legal.

For clarification, the Garmin bow site will only allow you to shoot where you have practiced and already shot accurately to. For example, with my bow, my Garmin Xero bow site will not allow me to shoot beyond 70 yards. Many sliders and other sites allow hunters to shoot way beyond that distance. With a hand held range finder, if you draw after ranging the animal and the animal moves, you have a very high chance of miscalculating and wounding an animal. With the Garmin you can re-range and make an ethical shot. This is way more ethical than lobbing arrows at guessed distances. It is not a magic site that guarantees success, I still need to practice shooting my bow, I still need to be an accurate shot. I still need to get within range of an animal and have a clear shooting lane. Archery hunters have such low success rates, we don't need more regulation to make it harder, especially when we have already invested money in our equipment that was and should remain legal.

Having said that I've choosen Pine valley as were I want to go and am willing to wait my turn in preference points to hunt there even though I'm a resident in Ogden I'm more than willing to use preference points and make the travel to hunt more mature type bucks on a general tag. Now the passed three years that unit has had severe drought and the biologists and conservation officers attested to that. The division made the right call in 2022 to significantly cut tags in Pinevalley and other southern units because of drought. You all preached through podcasts and articles why the tags would be cut and I 100% supported for the sake of the future of the deer within Pinevalley and other units like zion because those unit tend to hold more mature deer which many like hunters as myself choose to pursue. Now after 1 year of tag cuts you significantly increase the Pinevalley tags by 2000 tags over all weapon types and contradicting everything you did and said in 2022. Pinevalley and zion need recovery years from the drought. Just because we are having one high precipitation winter that doesn't undo the 3 years of extreme drought the mule deer herds suffered from. So I would like to ask you to reconsider your increase in tag numbers to be much lower in these units. It's hard to think its conservation when those high tag numbers would just means all the young bucks that were just saved be harvested. I understand the division tries to keep a balance with keeping hunters happy with the social aspect of actually getting a tag and going hunting. So I would like to suggest if tags have to be increased to a reasonable level then implement a two point restriction and let the young ones actually live a little and perhaps let the deer herds recover. Maybe allow the youth and senor citizens take a two point if they choose to.

Next I mentioned I live in northern Utah and as you already know our winter was bad! After seeing the small amount of proposed tag cuts for the northern units I was very discouraged that the division is not taking it more serious in reduction of tags. Mainly the cache, ogden, Wasatch front and back are my areas of focus and there is hardly anything left. As hunters we have to care about the species future. I preach conservation religiously but how can any of us think the take from hunting is necessary after mother nature has already taken more animals than any of us have ever seen her take. Please reconsider the northern herds because the proposed tag numbers is sad and we need to manage what left of the herd better.

While the central and northern portions of the state have suffered great winter mortality in out deer, the southern units have been much better. In my not so professional opinion, just boots on the ground observation, the deer units in southern Utah have been greatly impacted by the drought in recent years. (As you Know).

I have been happy with the tag decreases in recent years, especially on the Pine Valley. Last years tag cuts were amazing in trying to rebound the deer heard on that unit. We have had an exceptional winter on the Pine Valley and the current conditions there are adding up to help the deer rebound greatly! THAT REBOUND WILL NOT HAPPEN IN ONE YEAR! With the survival of last years fawns you are essentially issuing 1100 yearling buck tags.

It does not make any sense to not try and give the first decent fawn crop to survive in years a break... It also does not feel like we are managing based off our buck to doe ratio objectives. There are proposed increases on units that are below the three year average. Also, Pine Valley is on the bottom end of their three year objective but there are still massive increases proposed. Why cant we try and achieve the upper end of our buck to doe ratio or even be over objective before we increase tags? I feel like if we are within our ratio we should hold tags steady instead of issuing more tags. Over Objective= Tag increase. At objective=Stay the same. Under objective= Decrease tags.

There is no reason to increase tag numbers in southern units, especially Zion and Pine Valley. Yes, there have been good survival rates, but that will serve to increase the impact of continuing with the original proposal to significantly reduce tag numbers for 3 years in order to rebound not only the number of bucks, but also the age class. Theses units have been in severe drought and have been hunted hard the last 5 years, also the numbers are still well below what they have been or can be for this part of the state.

Secondly, having a mindset of "Hunt them while they are here" and "not stockpiling deer" doesn't make sense from a management perspective. The point of management is to ensure the hunting is good now and in the future. It is very shortsighted to only think about keeping tag numbers up to or as close to what they were last year after a winter like this. An overall reduction of 2% is a joke. Just because we can get away with it without completely destroying the deer population this year, doesn't mean that it is the best biological decision for the future of hunting in this state. The general season hunting will be so much better in terms of age class and buck to doe ratios in the next 3 years if we can handle one year of reduced tag numbers. A larger reduction in tags will limit the number of hunters, but we are already at 50% success rate in drawing tags anyways, so dropping that number a little more will not have as much negative impact on hunting as what is already being presented. Also harvest success % and overall hunter satisfaction will increase dramatically over the next 3 years due to more deer and more mature deer. Even this year the people who do draw will have a better hunt if there are less people in the woods rather than more. So it will definitely not negatively influence people's opinions on the DNR any more than what they already are. I want to hunt every year just like everyone else, but even I realize that on a year like this, for the sake of the animals, we have to make a sacrifice as hunters to ensure the future of hunting. That is the whole point of management, not finding a way to justify only reducing tag numbers by 2% so that the most tags can be sold.

This rule seemingly contradicts the new enforcement of meat waste management. If there is technology that helps locate injured or dead animals, we should allow it due to the ethical nature of wanting to be as efficient of a hunter as we can be for the sake of the animal we are pursuing.

Secondly, I would argue that banning the use of cellphones or radios to communicate with other hunters is more dangerous to humans than it is helping the animal have a "fair chance". I believe it will not accomplish what you are trying to achieve. The largest application that these items are used for is spot and stalk archery style hunts, and people can just use mirrors or reflective devices, light, or smoke signals to accomplish the same goal.

With respect to the 2023 permit recommendations proposed by UDWR for the Southern Region; I disagree with many of units having a proposed increased in permit numbers for the 2023 season. Many units including Beaver, Monroe, Dutton and Fillmore are either below their 3 year buck:doe ratio objective, or in the case of Fillmore, show a significant downward trend that correlates directly with tag increases the last several years that has put the unit on the fast-track to being below objective. How is this proper management of our resource? To increase tags on these units that are either below objective, or show obvious signs of a herd in decline is completely unwarranted. I do believe we have some northern Utah units that have suffered more this winter than in other areas of the state though and we should really be looking at cutting back tags further on units like Diamond Mountain, South Slope/Yellowstone, and the Cache unit. I don't think we have a complete grasp of how bad mortality has been there this year. Maybe we have the bucks right now, but let's be smart in planning for the overall future of these herds. We don't need to set them back inadvertently.

Second is a comment on the overall population objective for the Plateau Boulder/Kaiparowits. A year or 2 ago the new big game plan called for cutting the population objective on this unit...I can't remember the exact numbers...seems like cutting the objective from roughly 12,000 deer back to 8,500 deer. This is unacceptable to me. This unit used to produce a great deer herd. I feel like this was a step the DWR took in saying, "this is the best we can do, we give up on the higher population objective". This unit has been largely neglected compared to other southern Utah deer units in terms of both summer and winter range/habitat improvements and predator control, and collaring has only recently begun to really start to analyze the migration patterns of this herd. We need to get to work on raising this population objective again and getting a decent sized herd reestablished to what it used to be on this unit!

I agree with the idea of discontinuing the free replacement of permit for CWD positive game but I think that could be looked deeper into and offering a replacement permit at a cost. Even though a hunter has removed an animal off of the landscape, it is a positive in the fact of removing a CWD positive animal but there are questions surrounding keeping game meat from a CWD positive animal. Even though, as of now, there are no recorded incidences of CWD transfer from game meat to humans, and is still a choice a hunter has whether to keep or unfortunately discard that meat and if discarded, that hunter has lost all of that resource. At least offering a replacement at cost still provides the opportunity for a hunter to again potentially harvest an animal and hopefully not CWD positive because without obvious physical signs of disease, a hunter has no way of knowing if the animal is positive or not when taking that animal. Even though that hunter may take 2 animals off the landscape in total, 1 would have been CWD which should not stay on the landscape but the other would then be "counted as normal" so to speak.

I have two concerns, one is the archery portion and the use of communication devices.

As for communication devices, i strongly disagree with the proposal. I do fully understand that success rates are improved with radios, however i see the benefit using radios has on allowing more people-particularly children to be involved more with other peoples hunts. I went back over the last 8 year and hunts myself and my 12 & 16 year old kids have been able to be a major part of due to radios and helping and it is substantial. We as a family have gone on 9 different hunts that we assisted friends and neighbors with that my kids and wife loved being a part of. The level of involvement was different with each hunt, but the main connection was the ability to help via the use of radios. 80% of these hunts we were helping families that other children had the tags. We have been the direct connection via radios to direct hunters to the correct location at times and other literally sat back and watched and just used radios to pick up folks after walks. The point i make is my kids love to go help now as much as they do hunt with their own tags, with out the ability to use radios for "stalking" it can limit the involvement of others (especially children). I believe in and practice my own definitions of fair chase and do believe we need to regulate things, however i have a hard time with radios. I have personally seen the benefits my kids and other children have had by being able to be a part of a hunt through the use of radios. Furthermore, in the last 3 years, i was involved with 3 hunts that i personally was able to assist the hunters in either locating downed game after a shot or help stay of the wounded animal that re-joined the herd after the shot. A cow bison hunt on the Henry mountains last fall is prime example of both of my concerns. We had the opportunity to assist a youth hunter by spotting and directing them to a herd of Bison. After the shot the wounded cow gathered back with the herd, the hunter nor her father could tell which animal was wounded. I had a different vantage point that allowed my to stay on the correct animal and guide them to a follow up shot on the correct animal. Had i not been there and had the ability to help via radio she may have lost the bison or accidentally shot a different one. One other cow was coughing blood that confused the hunters. Lastly regarding radios, the enforcement side is a concern to me. If radios are still allowed in the field but not during stalking, this creates a challenge to enforce. Most of us will still use them for safety, to find each other, etc and that opens the concern for interpretation. Please re consider this portion.

As for a 25 year archer who recently (two years ago) switched to an electronic site, i disagree with this proposal. i mostly hunt with a rife/muzzleloader and agree with those weapons but not with Archery. In switching i have not personally gained any distance or greater effective shooting. It simply makes it funner and slightly quicker. I shoot a lot but don't archery hunt a bunch. Archery is still a very limited distance weapon and removing the electronic site does not change this that much. Thank you for your time, effort and consideration.

The agencies did all that work to rehab the BH fire and it has rebounded significantly. I added it up and we only have one elk per 5 acres inside that burn scar alone, not counting the rest of the 200,000 acres of elk habitat in the unit. We have the habitat, lets use it please. We need to get a return on the work and money spend there. collar the elk you will see they don't bother Gibb his property or allotments. For the new plan to be successful we need more elk

Do you have any additional comments about the buck deer permit recommendations?

I appreciate the opportunity to provide comments on the southern general season deer permit recommendations.

I provide my feedback from the perspective that we are coming off several years of extreme drought in southern Utah which has dramatically decreased fawn recruitment and hurt overall deer populations in most units. I am surprised to see the proposed general season permit increases after just one good summer/winter precipitation year, and can only assume that the DWR feels that the yearling buck recruitment will be so good that they can justify increasing permits now, immediately after years of healthy tag cuts, despite many units that they are recommending tag increases being below the approved buck:doe objective or directly at objective. I find some blaring inconsistencies in units I'd like to illustrate. I might emphasize the we hear all the time from the UDWR that we manage according to the management plan in place and approved by the RAC/ Board process, not to speculation or gut feel, or whatever else. We should not be looking at one good precipitation year and anticipated good yearling buck recruitment year as a trend, or basis for "feeling" that in 2023 units will see increasing post-season buck:doe ratios in November 2023. We manage to the plan and the plan says we manage for a 3 year average buck: doe ratio of 15-17 or 18-20 bucks per 100 does on all general season units.

- 1. The Beaver unit shows an average buck:doe ratio over the past 3 years at 15.1 bucks:100 does with individual years being 13.2, 14.8, and 17.3 bucks:100 does in 2020-2022. As you can see, this unit is not in compliance with the approved management plan of 18-20 bucks:100 does postseason. So it should be a candidate for permit cuts, however the UDWR is recommending a 300 permit increase from 1,500 to 1,800 for 2023. How is this justified?? I believe the Beaver unit should see a permit cut for 2023.
- 2. The Monroe unit shows an average buck:doe ratio over the past 3 years at 17.2 bucks:100 does with individual years being 16.5, 16.7, and 18..4 bucks:100 does in 2020-2022. As you can see, this unit is not in compliance with the approved management plan of 18-20 bucks:100 does postseason. So it should be a candidate for permit cuts, however the UDWR is recommending a 150 permit increase from 650 to 800 for 2023. How is this justified?? I believe the Monroe unit should see a permit cut, or at minimum, no change for 2023.
- 3. The Mt Dutton unit shows an average buck:doe ratio over the past 3 years at 16.7 bucks:100 does with individual years being 11.9, 17.4, and 20.6 bucks:100 does in 2020-2022. As you can see, this unit is not in compliance with the approved management plan of 18-20 bucks:100 does postseason. So it should be a candidate for permit cuts, however the UDWR is recommending a 100 permit increase (>30%) from 250 to 350 for 2023. How is this justified?? I believe the Mt. Dutton unit should see a permit cut for 2023.

4. The Panguitch Lake unit 3 year average buck:doe ratio is sitting at 17.1 bucks per 100 does, which is below objective, but no recommended cuts?? Why are the Beaver, Monroe, and Mt Dutton units which all have similar or lower buck:doe ratios, all seeing permit increases?

There is no consistency in following the approved plans when comparing one unit vs another.

5. The Pine Valley Unit 3 year average buck:doe ratio is sitting at 18.9 bucks per 100 does, which is directly in the middle of the acceptable range in the approved plan of 18-20 bucks per 100 does, with individual years being 21.1, 16.1, and 19.4 bucks:100 does in 2020-2022. Yet an enormous 1,100 permit increase is recommended from 1,700 to 2,800 for 2023? How is this justified?? One can only conclude that the UDWR is anticipating a good yearling buck crop next fall and so the recommended permit increase is justified. But an anticipated great 4th year of yearling buck recruitment, is not a metric the plan calls for when setting permit recommendations. I believe we should leave the Pine Valley with no permit change for 2023.

To further illustrate the inconsistency among big public land southern Utah units lets look at another unit.

To use the San Juan Abajo unit as an example The San Juan Abajo unit shows an average buck:doe ratio over the past 3 years at 20.9 bucks:100 does with individual years being 20.3, 22.6, and 19.9 bucks:100 does in 2020-2022. As you can see, this unit is in compliance and at, or even slightly over objective all 3 years. It is in compliance with the approved management plan of 18-20 bucks:100 does postseason, and could even be justified for a permit increased. But even with a 3 year buck:doe ratio of 20.9, the UDWR is recommending NO permit increases, and it recommended to leave as status quo for 2023. How is this justified??

How can a unit like the San Juan Abajo unit which is over objective see no permit increases, and the Pine Valley which is a full 2 bucks per 100 does lower than the San Juan Abajo Mt unit and in the perfect middle range within the plan, see a 1.100 permit recommended increase. There is no rational explanation.

In conclusion, as we come out of one of the hardest winters in the last 40+ years, it is inconceivable that the UDWR's general season deer permit recommendations are a measly 1,500 less than in 2022. How is this possible? One can only conclude that the bigger cuts in the north must be offset by increases in the southern part of the state, to try and keep the overall tag numbers somewhat comparable, even if they are not warranted or justified as I've pointed out. The UDWR seems too eager to increase tags with just one year of positive precipitation and only anticipated, but not actual population or buck numbers increasing yet.

I highly suggest that the southern RAC consider the data presented against the approved UDWR management plan in place, and do not increase permits where there is not a basis for doing so.
