I disagree with making Trumpeter swans illegal to harvest. We have an increase of 100k Trumpeters and we are not going to manage them? Trumpeters are not listed as endangered or even a threatened species, other states have tried to implement a season on them and were unsuccessful due to anti-hunting pressure. The Central Flyway portion of Montana has even lifted the restrictions on the taking of Trumpeter swans and we are going backwards?

I also believe you are not comparing apples to apples on bird identification, ducks and geese are highly distinguishable from one another. I have guided and hunted swans for 30 years, if a Trumpeter is silent or not flying with Tundra swans, they can be almost impossible to tell apart on the wing. We have made it unsportsmanlike to land birds and shoot them on the water and this would be the only way to be 100% certain, after viewing it in binoculars to tell them apart.

If we must wait on FWS to come back with isotype testing and by the data I would rather see tag numbers reduced and a closure of the Northern boundary. I would like to see Utah work closely with FWS and push for an increase of study to see what population of Trumpeters we are harvesting; do they need to be managed?

North Peaks CWMU has 2,040 acres of public land, not landlock, and is accessible to the public hunter incorporated into the CWMU. As of now, there has never been a process to evaluate the tradelands and if it is equal habitat for the public land they have Incorporated into the CWMU.

These two pieces of private land actually give the public hunter good huntable habitat with a county road thru it. It supplies good hunting for both elk and deer. Also, these 2 pieces of land used to show up on a tradelands map and were available to the public hunter. Apparently, the map has been deleted from Utah Hunt Planner. They claim it was wrong, but the map has been available to the public on the Utah hunt planner since the fall of 2019. Because these lands show up as tradelands for a good part of the application process and because there is no process for the Division of Wildlife to actually evaluate these lands, and no Wildlife or habitat biologists signed off on this. then I believe it should not be passed.

100,000 more trumpeters migrating through? The Rocky Mountain population is just shy of 12,000 birds according to the Pacific Flyway RMP management plan. If 100,000 trumpeters are migrating through Utah, then, the quota is meaningless.

Additionally, it is important to better publicize the fact that even at 11,700 birds, the quota could be harvested every year and would have absolutely NO IMPACT on the RMP of trumpeters. The media does NOT publicize that fact and makes it sound like the 20 birds harvested are threatening an endangered species.

Why is th radio isotope survey taking so long? There are at least 3 years of data already. We've been told for two years now that we will have data, "in a few months," or, "later this year." What is the hold up?

- 1) Given that the majority of trumpeter swans are being killed at Public Shooting Grounds, the most simple, and easily enacted change is to remove PSG from the boundaries of the hunt unit. Return to the boundaries that were in effect when few trumpeters were being killed.
- 2) Enforcement will be difficult. People will leave trumps to be eaten by eagles, harriers, and raccoons. This will further deplete the Rocky Mountain population.
- 3) Start the swan season two weeks later. Prior to the recent changes, the hunt started later.
- 4) Split the hunt unit into two units; a northern GSL unit with an earlier start and finish dates; a southern GSL unit with a later start/finish date.

FINALLY, I appreciate the work that DWR is undertaking to deal with this issue and to preserve a unique and thrilling opportunity to hunt swans--my favorite waterfowl hunt.
