



# 2006 Utah Resident Sportsman Permit Application Instructions

1. Enter your personal information here. \*Be sure to include your Hunter Education number if you were born after Dec. 31, 1965.
2. Select hunts you would like to apply for by writing \$5.00 in the box next to the hunt.
3. Write the amount of your Sportsman donation here. Make sure to include this amount on the Total Due line. (Donation Optional.)
4. Add handling fees and any Sportsman donation amount and write the total here.
5. Sign and date the application. An unsigned application will be rejected.
6. Check box indicating method of payment. Make checks payable to Utah Division of Wildlife Resources (UDWR). (Personal or Business checks drawn on out-of-state accounts will not be accepted.) Do not combine checks and credit cards for payment.
7. If using a credit card, enter ALL the information here as it appears on the cardholders billing statement. Double check the credit card number and expiration date (must be good through 01/06).
