A person who has obtained a limited entry bear permit that allows the use of bait may apply for a Bear Baiting Certificate of Registration. A new COR must be obtained prior to moving a bait station. The following items must be provided with this application. The GPS Coordinates (UTM, including the datum, or latitude and longitude of the bait station, including the datum, type of bait used and written permission from the landowner or verification from the district office of the federal land management agency that the proposed site is open to baiting. Once all information has been obtained, complete and submit this application with the required \$10.00 nonrefundable handling fee to a Division office. The regional office where the bait station will be established will review the application and upon approval it will be mailed to you at the address provided.
