

## Resident Application for General or Master Class Falconer Certificate of Registration (COR)

**New applicant:** If you are transferring from another state upon completion of the residency requirement, you must submit a copy of a valid falconry license from the former state of residency indicating class and a valid federal falconry permit. <u>General Class</u>: Apprentice falconers wishing to upgrade to General Class should contact the Salt Lake Office at least one month prior to applying for a General Class COR. When applying for the first time you are required to have authorization from the falconry program coordinator concerning your qualifications regarding upgrading to General Class Falconer. <u>Master</u> <u>Class</u>: General falconers wishing to upgrade to a Master Class should contact the Salt Lake Office at least one month prior to applying for a Master Class COR. When applying for the first time you are required to have authorization from the falconry program coordinator concerning for the first time you are required to have authorization from the prior to applying for a Master Class COR. When applying for the first time you are required to have authorization from the falconry program coordinator concerning your qualifications to become a Master Class Falconer.

**Renewal applicant:** <u>General Class</u>: Submit application by the expiration date specified on your current COR to falconry@utah.gov. This will allow you to maintain raptors in your possession without being in violation of unlawful captivity of protected wildlife under Utah Code § 23A-5-302. If you have not held a Falconry Certificate of Registration for five consecutive years, re-examination and facilities inspection are required and you can contact <u>falconry@utah.gov</u> for assistance. <u>Master Class</u>: Submit application by the expiration date specified on your current COR to falconry@utah.gov. This will allow you to maintain raptors in your possession without being in violation of unlawful captivity of protected wildlife under Utah Code § 23A-5-302.
