

Application for a Utah Commercial Hunting Area Certificate of Registration (COR)

- Large scale map(s) clearly depicting the location of the CHA, and game bird holding facilities relative to the nearest city or town (digital maps accepted – send to DWR-CHA@utah.gov). AND
- Copy of a title, deed or tax notice that establishes proof that the applicant owns the property described.

OR,

- Copy of lease agreements(s) that establishes proof that the applicant is the lessee of hunting or shooting rights on the property described for the period covered by the Certificate of Registration.

Renewal Application (Due May 1):

- Required fee (\$150.00, Checks payable to Utah Division of Wildlife Resources), AND
- Detailed map(s) clearly depicting boundaries, game bird holding facilities and ownership of all parcels within the CHA. (digital maps accepted – send to DWR-CHA@utah.gov) AND
- Large scale map(s) clearly depicting the location of the CHA, and game bird holding facilities relative to the nearest city or town (digital maps accepted – send to DWR-CHA@utah.gov). AND
- Copy of lease agreement(s) applicable to the three year renewal period (if land is leased), AND
- Annual Report, AND
