If the limit of hooks is lowered can there be talk a out allowing 2 set line permit holders to combine the hook count to 16 but no more on a single set line. as long as both permit holders are present and both active checking the set line. If the 15 hook count stays lower the time to check to every 10 hours. It reads that you have to be present and near the set line at all times. Pushing the time to 48 hours opens it up to illegal leaving of fishing gear. One more thing I would love to see is more bodies of water open to set lining. Ie lower green river below vernal. And pelican lake to target carp mostly.

Utah Anglers Coalition is a statewide association of varied angling interests dedicated to the protection, enhancement, and enjoyment of Utah's aquatic resources and angling opportunities.

Recently, UAC met with the Division to discuss at length the proposed regulation changes for 2025. Some of our members are opposed to this regulation change due to their concerns about public safety with unrestricted hole size. First of all, I want to make it clear. I am not against anyone pursing their passion or craft. I am not arguing against spear fishing. However, I believe there should be a check and balances when it comes to the taking of fish in the sport of spear fishing.

I think the new proposed regulations of allowing spear fishing at night with artificial light for chub only, opens up a can of worms. From a walleye angler's perspective, this regulation change is specifically targeted to the exploitation of walleye.

During the spring, walleye are vulnerable. This is especially true at Deer Creek and Starvation. Walleye gather in hug schools in the same locations year after year. These schools include the large females that are easy targets for spear fishing. They don't spook easily and can be taken at will. Additionally, there is no law enforcement at night. I feel we are giving the fox the keys to the hen house by implementing the use of artificial light at night for spear fishing.

I am personally against the regulation change. Allowing spear fishing at night with artificial light for chub is not enforceable. And leaves to door open for exploitation of our walleye population.

I am asking for a compromise. Close Starvation, Deer creek and other walleye water bodies to all spear fishing from March 1st - May 15th. We protect spawning bass and trout. Why are we not protecting our walleye fisheries?

I would like to comment about the proposed rule changes for Manning Meadow Reservoir and Barney Lake. I frequent both lakes and both are treasures in the fly fishing community. They are the only Artificial fly and lure only lakes for many miles and I believe they should stay that way. The last Net Survey at Barney Lake was conducted in 2020 and since that time, it has had significant winter kill due to the drought two years ago and it will not recover if bait is allowed there. It is a pristine lake with very little parking. There are numerous other lakes on the mountain and surrounding areas which allow bait. The DRW web sight describes Barney Lake as a "small lake perfect for float tubes." The Southern RAC voted to not allow bait fishing at these two fisheries. I respectfully ask the Wildlife Board also vote to not allow bait at Manning Meadows and Barney, but also allow the taking of four fish at both waters, to protect this limited resource to those to have come to cherish this area for the opportunities it provides. Manning Meadows has been described as one of the best dry fishing spots in Utah.

The proposed changes to Manning Meadow and Barney Lake need are unnecessary, and the Southern RAC agrees and voted to eliminate the proposed changes to these fisheries. These lakes provide two of only a a few opportunities specific for fly/lure anglers. I am opposed to changing the regulations at both lakes, however, I am extremely opposed to change at Barney Lake. I voiced my opinion at the Southern RAC meeting and noted some of the following issues:

The fish population is not healthy as is being presented in the presentation video. Barney Lake experienced winter kill in the winter of 2021-2022, as well as 2022-2023. This is confirmed on the DWR Fish Finder Website, as well as by Mr. Mike Hadley at the Southern RAC meeting. There is no reason to change regulations to this lake in order to help reduce fish population. It was noted in the meeting that the real reason for the change was because it needs to follow the same rules as Manning Meadow. Manning is a fly fishing destination and is literally the premier dry fly fishery in southern Utah. The fish population is healthy, providing great opportunity to catch quality 14-18" cutthroat trout. Although the fish do not get much bigger because of the healthy population, the angling community is happy with the quality of fish that are available at the lake. Local comments and questions were heard at the Southern RAC meeting, and the Southern RAC Board voted UNANIMOUSLY to keep the fly/lure restrictions in place. The Wildlife board should support the recommendation of the Southern RAC and again vote to strike down the recommended changes and keep the fly/lure restrictions in place. Southern Utah only has a few lakes/reservoirs that have these restrictions (Manning, Barney, Minersville, & Kolob (partial year)), there is no need to take away what is already limited opportunities for these type of fisheries. Taking these away would essentially make Minersville Res the only true fly/lure only location, which is unreasonable for a region as large as the Southern Region. Again, please listen to the Southern RAC and their vote, and please consider that the fish populations at these two locations are in no need of reduction through the use of bait, especially Barney Lake, which was confirmed by the DNR Biologist at the RAC meeting. If you are not going to follow the recommendation of the Southern RAC, then I am not sure why they are included as part of the process. Thank you for your consideration.
