Do you have any comments about the buck deer permit recommendations?	I vehemently opposed pulling the Cedar mountains from the West Desert West. The Cedars are FAR different than the Stansbury mountains. The deer populations on the Cedars are minuscule compared to the Stansbury mountains. There aren't 1150 total deer, including does, on the Cedars. To take the overall total number of hunters that could potentially hunt that range from 450 to 1150 is absolutely idiotic, and I feel like it will lead to irreparable harm to that deer population. All of the units that were affected by these boundary changes had combined permit numbers of 2757 for 2024. Deducting the Cedars from the West Desert took 50 total permits away from that unit. By that logic, there were actually 2357 total tags allocated to the Cedar/Stansbury/Oquirrh/Tintic cluster. There are 3600 total for the Cedar/Stans and Oquirrh/Tintic hunts now. Anyone that's spent any amount of time on any of those units knows that deer numbers haven't rebounded enough to justify a 1300 permit increase. I get that the rhetoric coming out now is that buck numbers don't drive population numbers. That's fine. I do want to point out that you do actually need a few bucks to make sure all the available does are actually bred, though.

The reasoning for limiting the Cache Limited Entry Muzzleloader deer tags doesn't make sense when taking in the context of all tags on the unit. The reasoning for keeping the number of muzzleloader tags low was to let the animals have a chance to recover from the previous winters. It doesn't make sense when you look at adding several hundred tags to the general hunt only 10 days earlier. In order to keep the reasoning consistent and fair, I recommend either cutting the number of general tags (goes against why they wanted restricted weapons) or increasing the number of limited entry muzzleloader tags to levels consistent with other general units and give more opportunity for limited entry hunts.

Hunted 2024 on Tabyona Mountain and the Red Creek area above Reid Ranch. The last three years deer numbers and elk numbers have seen a significant decrease in total population. While deer from those areas winter on Taby Mountain it is an inaccurate picture of the unit numbers. Where we used to see 60 or more deer on the opening weekend we are seeing numbers below 20. Some hunters in the area above Reid Ranch saw 0 buck deer on the opener. This is a significant change for this unit. We spoke with the rancher who has the grazing permits in this area and he also confirmed that numbers were way below what the unit held prior to the winter of 2022.

I have hunted Northern Utah for over 50 years. The last three years my group went from passing on bulls to seeing no elk on the opening day of the early hunt. We hunt the Spirt Lake area of Flaming Gorge and have been in this same area for over 35 years.

I've hunted that unit a lot of years in my life and there's no way it can support the amount of tags proposed. They have proposed a 55% increase on this unit as its first year being split off from the beaver west unit. Do you have any comments about As a lifetime resident of the Beaver unit, specifically the Beaver East I would like to provide some important information concerning increasing tags by over 50 percent.

> The Beaver East is made up of Canyons, slopes, draws and flats all full of sage brush and bitter brush a favorite food of the mule deer. Also scattered in different locations are necessary ponds for the deer to get water.

> Increasing tags of this magnitude is a recipe for disaster for the buck population in this area. The area already has too many small deer harvested each year because of its open sage brush landscape, which does not allow any mature deer to survive. The open country is easy pickings for the long range rifles, optics and ability to go anywhere on an ATV. No deer are safe under these conditions. With total deer numbers down, it is important that we try and allow as many deer as possible survive.

> Weather on the Beaver unit was as dry as I have ever seen it. For the first time in my 60 years I was able to drive a pickup into areas that have never been possible in other years. I was also able to get out and hike these canyons with out any snow at all during December and January. One thing I did observe is that the deer numbers just do not match that of the divisions. I was able to walk everywhere and there just is not the deer population that is being presented in these meetings. It is just not so. I know your hear this everyday from sportsman on the ground, and I can tell you that I spent almost everyday for 2 months on the Beaver East and the numbers just do not add up. The same is going to be stated on the Beaver west. So if they are not in either place it would be interesting to know just where they really are, The reason the Zion and the Pinevalley did not receive tag increases was stated it was because of weather, yet the driest I have ever seen it on the Beaver and they are going to increase it over 50 percent. Does this make any sense?

The Southern rac also recognizes and sees what we are seeing and voted on a much smaller number on both the Beaver East and Beaver West. This rac knows the current reality of our deer herds.

If local racs are not listened to, then why do we have them. How many times have you heard racs say that they know the current reality in their own area, but know nothing in other rac areas. That is the reason for the different racs. they know there area and they are willing to stand up and say what they know in their areas. Please listen to the local rac areas,

I would encourage this board to listen to your current rac

members and use them as a great resource in each of the areas. There is no reason they would lead you astray. They want what's best for the deer herd in their respective areas. Please listen to them.
