The RAC asked questions surrounding the logistics of requiring CWD testing to be mandatory for all hunters. The RAC asked how confident the DWR is in the growth of the disease across units considering the lack of abundant samples. The RAC asked if the DWR was also testing roadkill deer/elk for CWD. The RAC questioned if there has ever been a proven transmission from a CWD positive animal to a human. The development of a potential vaccine to treat someone who has CWD was also discussed. The RAC asked how the DWR plans to implement the mandatory testing for CWD in the Ogden unit.

### **Aquatics:**

- Panguitch Lake Siphon Project:
- <u>Need:</u> Water quality issues from high nutrient levels threaten fishery (low dissolved oxygen) and ability to recreate (harmful algae blooms, etc).

- Goals and Strategy: Maintain excellent fishery and recreational opportunities by installing a siphon to pull water from deep part of lake where it is high in nutrient levels and low in oxygen.
- **Status:** Currently in planning phase (design, funding, permitting) and intend to implement in fall of 2026.
- **Sport Fish:** Completed project on Twin Creeks boardwalk and parking area in Fishlake. **Kokanee** egg collection successful, food web study is nearly complete.
- <u>Lake Powell:</u> Completed fall gillnet surveys and year-long creel survey. Low water level hit **Shad** and older **Striped Bass** hard, but still a healthy population. Total angler hours down, while angler catch rates were up. Increasing water level would help everything.
- <u>General:</u> Wrapping up field season work, transitioning to data, reports, project proposals, meetings, etc. Need a good snowpack to avoid drought issues next summer and fall.

#### **Washington County Field Office:**

- <u>Desert Tortoise:</u> Finished plant restoration project in Red Cliffs National Conservation Area (2017-2025) to assess plant growth/survival; local volunteers helped to collect plant cages and stakes.
- <u>Western Toad:</u> Released 278 toads on the Paunsaugunt Plateau in August/September.
- <u>Mollusk:</u> Collecting **Springsnail** samples for genetic work to update abundance and distribution records in the state.
- Woundfin: Approximately 300 fish were successfully transferred in a UDOT plane from Southwestern Native Aquatic Resources and Recovery Center (NM) to Aquatic Animal Health and Research Center (UT).
- <u>Santa Clara River:</u> Native fish have persisted following fall rainstorm events (concerns with run-off from Forsyth Fire). **Virgin Spinedace** (n=8) were collected and transferred to Loveland Living Planet Aquarium.

#### **Habitat:**

- Work underway on Monroe Canyon Fire Rehab, contracts are out for France Canyon Fire Rehab, and contracts will soon be out for Forsyth Fire Rehab.
- Lots of lop and scatter, cut and pile, mastication and Rabbit Brush Mowing contracts going on.
- New Cedar Area Restoration Bio David Montague started in October, will be hiring new NRCS partner biologist in next few weeks.
- Successful grass bank permit helping grazer affected by Monroe Canyon Fire.

# **Outreach:**

- Wild game cooking clinic with local vendor was under attended, but participants went home well fed.
- Regional pheasant hunts went great, lots of birds harvested (Cedar City, Annabella, and Pahvant).
- **Hunters helping Condor** stations wrapped up last month. 250 people visited the station, over 130 hunters entered into the prize drawing.
- Dedicated hunter program still has projects available for service hours. Hunters are reminded to submit their harvest reports.

# Law Enforcement:

- Busy fall for our officers.
- Officers in the region investigated over 60 cases during the month of October, 2025.
- Focused on finishing up on investigations and moving cases through the court system.

Presented the Division's recommendation and answered questions from the RAC and public members. CWD has been in Utah for some time, we have had some struggle in obtaining right sample sizes. Goal is to obtain 300 samples from our target units. We rotate our units every five years. We have not had very good hunter participation in the past. Ogden unit will have mandatory CWD testing for general season Deer hunts, start small, may expand mandatory testing to other units.

# 06:18:44 | RAC Questions

- **Bryant Johnson:** We are moving towards mandatory testing in the future.
- Next year will begin with Ogden?
- Usually people associate CWD with Deer, but can't Elk get it the same way?
- 2002 was the first year, we saw CWD in Utah. Recent hunt in Colorado, there was mandatory CWD testing. Told CWD was in Utah since 1970's.
- Are there not enough samples from road testing?
- **Ginger Stout:** Yes, mandatory testing in future, starting with Ogden units
- We are worried about Elk as well, particularly in this unit, where we saw it in Elk first. We are starting with Mule Deer, then start with Elk.
- We began testing in the 1990's.
- Roadkill plays a big role, but it doesn't tell us what's going on across the
  unit. We have a point system, weighted towards the suspect in roadkill
  and it gives us more points to add into the total.
- **Bart Battista:** Do you coordinate with county sheriff's departments regarding roadkill and what they pull from the road?
- **Ginger Stout:** There have not been any coordinations, but we are working with UDOT and the contractors that pick up roadkill and the next step will be with law enforcement.
- Chuck Chamberlain: What does the analysis cost?
- How much and it takes two-six (6) weeks to get sample results?
- If we need 300 Deer, I assume there is a waiting list.
- **Ginger Stout:** \$35.00 per sample.
- Bart Battista: How does the weighted scale work?
- **Ginger Stout**: The weighted scale gives a certain value for suspects, roadkill. Bucks are weighted higher than Does.
- **Bryant Johnson**: Is there ongoing testing to try to work towards a cure.
- With all of our Deer captures, there aren't any blood testing going on?
- **Ginger Stout**: No cure for CWD, it is fatal. We are working on different tissue types, no validated tests for live animals. There are a lot of studies and research going on.

- We are taking blood samples, ear punches, nasal swabs, and feces from captured animals to see if we can detect this in live animals.
- Most important is education. Found hunters don't know much about CWD, working on education and marketing campaigns.
- Encouraged everyone to submit samples for testing.
- Russell Gardner: Is there a time limit that the sample can be collected and submitted?
- **Ginger Stout:** Yes, we'd like it within 24-48; however, if you keep it cool it can be longer. We can even take the sample if it's frozen.
- Chuck Chamberlain: You mentioned mandatory testing in Ogden for a year or two. Are you concerned this isn't moving fast enough to curb CWD spread?
- **Ginger Stout:** Valid point. Educating hunters on how to take their own samples and increasing drop off places. Trying to make it easier for hunters.
- **Mike Grant:** Are you just wanting Ogden samples? Or will you accept samples across the state?
- **Ginger Stout:** Yes. We have a five-year rotation of all Deer units. If it's outside those target areas, we can't pay for every sample submitted.
- **Chris Cannon:** Are you anticipating resistance to mandatory testing?
- **Ginger Stout:** We haven't experienced resistance, but we are starting slow with mandatory testing.
- **Chad Utley**: Presentation indicated CWD is passed environmentally. Can't you test Deer droppings?
- **Ginger Stout:** That is one of things we are sampling to see if it gives us valid test.
- **Bryant Johnson:** Let's say we test for it and we have it and it's getting out of hand.
- Touchy subject reducing Buck to Doe ratio.
- **Ginger Stout:** We know we will have it, we don't want it to become prevalent. Education campaign to educate hunters on proper practices on dispose of carcasses, etc. Don't want prions to move from unit to unit across the state.

	Keeping Buck to Doe ratio lower to lessen spread. Each area is different it would be very specific to an area.
	Kevin Bunnell: We have done that and it's very localized. It's not the whole unit. It stays within a particular part of the unit.

- Likes what the Division is doing with the extended archery and boundaries in the presentation.
- Have you thought about having a provision of shutting the hunt down if we get into a severe winter? Even though the idea is to get them off the agricultural land. Hear about not harassing wildlife, etc. Optics to the public may not be good.
- Sam Robertson: Not sure when the archery hunt changed, but is has been the last hunt for the last little bit.
- Eight day hunt because that's where the calendar falls at the end of the year.
- The hope is that adding the hunt will limit that pressure. Some of the hunts can get too many hunters at once.
- Archery success rates since 2007, the time it took to harvest was 6.4 days.
- The number of days is based on the calendar, it has been over eight days.
- Yes, there are reason we could shut hunts down if things get drastic. The boundary on this hunt is primarily private.
- **Kevin Bunnell:** One of the things our Director has the authority to do is shut down a hunt if there is an emergency situation on short notice.
- Chuck Chamberlain: Is there any concern about accessing that private land? Years ago he hunter in Logan and it was 95% private, couldn't find a single landowner to let him on their property. Is there access to public?
- Sam Robertson: There are landowners that are so fed up with Elk, they'll be allowing hunters on their land to hunt. We also have a couple of walk in access areas.
- **Mike Grant:** Looking at the hunt tables on the Henry Mountains with the new hunt. Sixty-three days and nine days break. We're pushing those Bison and we want to add another hunt so more can be successful. They don't have a break now. 100 percent in favor of hunter opportunity.
- So, this will be specifically a new hunt due to drought?
- Part of this was an emergency because of drought conditions. Adding another hunt if permits are added on, they can go to a certain area.
- Does the hunt start this year because of the drought? Or next year, the drought might not be as bad.
- **Sam Robertson:** Part of this in response to drought conditions. You won't see a max of 30 permits given out every year.
- This will be in place for the next couple of years, and then it will be looked at and revised as needed.

- **Bryant Johnson:** You're looking at increasing your size of that herd?
- What was that split again?
- **Clint Sampson:** Yes. Recommending a split, having a sub-unit on the Bitter Creek area and another one is Little Creek (roadless area).
- Found Bison are very susceptible to hunting pressure and habitat treatments.
- The animals on the Bitter Creek unit do not leave. They stay on public land. Have not ventured into Colorado much up until now.
- The other herd we deal with is a migratory herd. They show up right before the rut. They will show up in July and stay until the snow drives them out or it melts in the spring and they migrate out and show back up on tribal land.
- That fluctuation has affected the ability to manage that herd.
- By splitting it and making it two separate objectives. It will provide a better hunt for sportsman on the Bitter Creek unit.
- Bart Battista: You want to increase the population from 450 to 650 and distribute them more so there is less impact.
- Have you analyzed or given a prediction of what that increased impact with look like?
- Clint Sampson: Envisions it being spread out like it is now. We'll be able to grow them at a slow pace. We've been able to keep the Bitter Creek down to the low 100's as far as total number. We can grow them at a small enough rate so we can adapt as we see changes.
- **Bryant Johnson:** Are some of them going into Colorado?
- Do you foresee them wanting to hunt Bison on that side of the state line?
- **Clint Sampson:** Most of our collar data shows they go up to the Colorado border and stay right there.
- Colorado does not value them as a wildlife species and they usually are shot if they cross the border.
- January 1<sup>st</sup>, Colorado will consider them a protected wildlife species.
- Will leave the Bison hunting in Colorado up to them.
- **Chris Cannon:** Do any of these Bison end up on Ute reservation land?
- Clint Sampson: That herd that migrates on and off the Little Creek unit, usually May to June, they will end up on Ute land. When we fly in the winter we can see aware form 300-500 animals.

The new hunt structure looks positive. There are gaps between, let's the animals relax. As soon as they get too much pressure, they moved back to the tribal land. • **Kevin Bunnell:** Received a text from Covy Jones. Colorado legislature changed the Bison to protective wildlife. Their wildlife agency is working on a rule and management plan. • **Brooklyn Cox:** What is the justification for doing this? There's an increase in forage and changes to grazing practices. With this new plan, is there an ability to work with grazers? Is it a lifestyle change? Or is it a Bison grazing practices? Still opportunities for conversations to happen? • Clint Sampson: Works with the one permittee (Clay McKeachnie) who is actively grazing there right now. • Good communication, work well with improving habitat, springs, etc. • Chris Cannon: Did the Utes have a harvest objective? Do they coordinate with you? • **Clint Sampson**: We do work to coordinate with them, some years are better than others in what information is shared. Most of the time there's a curtain there. • Bryant Johnson: Were we able to get access back to cross that onemile area? • Clint Sampson: Yes, if you are a sportsman and you want access, you can request an access permit for tribal land. # SUBJECT: Recommendation for season variance on Blackhawk and Hiawatha CWMUs

In 2024, the Blackhawk CWMU requested a variance to extend their bull elk hunt season until December 15, based on the rationale that elk movement onto the CWMU often occurs late in the year. The initial request was tabled while the Division of Wildlife Resources (DWR) determined its compatibility with current CWMU administrative rules. Subsequent review confirmed that the request is permissible under existing administrative rule.

Consequently, two variance requests to extend bull elk hunts to December 15 for both the Blackhawk and Hiawatha CWMUs were presented to the CWMU Advisory Committee on August 4, 2025. The Committee recommended approval of the variance for Blackhawk for the current hunting season, in light of their 2024 request, and for the Hiawatha CWMU beginning with the 2026 hunting season.

This recommendation is being brought forward to the Wildlife Board for authorization of the specified variances for these two CWMUs, as outlined by the CWMU Advisory Committee.
