You get a handful of days to chase cows with hundreds of other people (similar to public Hunting) unless you schedule a 3-4 hundred dollar private date. It seems to me Wild Country is gaming the system. I have been fortunate to draw Deseret several times over the last 35 years and I have never seen such disregard for the public antlerless hunter as the last 3-4 years has shown.

STRONGLY DISAGREE - can't express how poorly thought out or scientific the decision is to ban electronics on archery equipment. Looking at facts alone, the Garmin ranging bow site was introduced in 2018 - this is the largest "technological advancement" that this regulation is directly targeting. Therefore, we should be able to see scientific evidence that shows an increased success rate IF this technology gives an "unfair advantage" over the game that is being pursued. Here are the facts. Over the last 10 years here are the average archery success rates in general units across the state:

2014 - 21.13% 2015 - 24.87% 2016 - 23.09% 2017 - 20.54% 2018 - 23.17% (Garmin Introduced) 2019 - 16.47%

2020 - 19.61% 2021 - 18.08% 2022 - 19.30%

2013 - 18.80%

As the data shows, there is no scientific, mathematic, or factual data showing that archery or hunter success rates have increased due to the introduction and usability of an electronic device on a bow. In fact, the data shows the opposite.

Moving away from the scientific and factual data and onto the common sense side of things - why would we want to make a regulation that reduces an archery hunters ability to taking an ethical and precise shot? Why would it be something we put a restriction on in August, just to allow a Muzzle Loader the ability to take a 400 yard shot in September? Or a rifle hunter to take a 1,000 + yard shot in October? If we're talking about ethics, using an electronic sight on a bow is arguably more ethical then a fixed pin where the archery has to guess the range and take a non-precise shot.

In the past year, I have hunted and spent a significant amount of time on the Zion, Panguitch Lake, Wasatch East, South Slope Yellowstone, and Kamas units.

Starting with the Zion deer unit: the quality of deer has declined dramatically over the past several years due to extreme drought. In 2022, the Wildlife Board reduced the permit allocation from 3,100 to 2,325 permits. It was not enough. To increase those permits to 2,900 permits is reckless. If anything, the permits should remain at 2,325 permits in 2023 to account for compensatory mortality caused by the 316% snowpack as of April 5th. These deer are starving to death and no increases in buck permits should take place and no doe permits should be issued in 2023.

My comments for the Panguitch Lake unit are similar to my comments for the Zion unit with the exception that 1,700 permits were issued in 2022 and 1,700 permits are being recommended for 2023. The permits should be reduced to the 1,200 permit number used in 2021 to account for compensatory mortality this winter with over 300% snowpack. No doe or cow permits should be issued for this unit in 2023.

I will turn my comments to the Wasatch East, South Slope Yellowstone, and Kamas units. The permits for the Wasatch East deer unit have been constant at 4,250 for the past three years. I would agree with the permit allocation for 2021 and 2022, but not for 2023. Deer and elk mortality this winter with 222% snowpack has been extremely impactful to the deer and elk populations. I would recommend reducing the permit allocation by 20% to account for the exponentially higher winter mortality rates. The same should be applied to the South Slope and Kamas units. The DWR has recommended decreasing the South Slope Yellowstone permits from 1,300 to 1,000 - and I agree with that proposal. For the Kamas unit, the DWR has recommended decreasing buck deer permits from 2,800 to 2,200. I would recommend a decrease to 2,000 permits for the Kamas unit.

Above all else, we know that bucks can't have fawns, and I would like to plead with the RAC committees and Wildlife Board to not issue any doe or cow permits for deer or elk in 2023. We need those females to reestablish our herds after this incredibly harsh winter. I live in Summit County and have personally identified over 200 dead deer and elk within 2-miles of my house this winter due to roadkills and starvation.

That has to be the worst statement for wildlife management that could possibly be conceived during a year with 200%+ snowpack and up to 800 inches of total snow in some areas of the state. It is inconceivable that moose, rocky mountain, and mostly mountain goat populations will not be impacted by this past winter's snow accumulations. I live in Summit County and have personally identified over 200 dead deer and elk within 2-miles of my house this winter due to roadkills and starvation. The moose that I have seen have all been right along the fences near the highways searching for food in snow past their bellies. Mountain goat populations along the Wasatch Mountains and in the Uintah will have experienced die-offs that we have not witnessed since we began managing these populations in Utah. I will also note that I have a Master of Natural Resources degree and everything that I have ever learned tells me that proposed permit allocations for northern Utah are extremely high and not conservative in the slightest. This is a year to lean heavily on being conservative and thinking about the future more so than the present year.

I have 19 mountain goat points and would potentially draw a High Uintahs permit this year. However, I am hedging my bets that the hunters who do draw this year will have an eye-opening negative experience when they attempt to find mountain goats after this winter's storms. It's not worth two decades of applying to obtain a permit without knowing that the population of mountain goats is still intact and growing.

I like that there are unlimited youth general season permits. It is extremely hard for youth to draw deer permits, and this allows parents to introduce these kids to hunting and keep them hunting every year.

I do like that the permit increase on limited entry units is being increased incrementally so we do go past our estimations.

I do like reducing the number of early-season elk tags, but those mid-season hunts during the spike hunt are going to be a huge challenge and there will be a learning curve for hunters.

I have 21 points, so I won't go for a late-season archery hunt, but I think that is a great opportunity hunt.

HAM hunts are just muzzleloader hunts. Why not just make them a muzzleloader hunt? Thank you for removing several of the HAM hunts and making them general season hunts.

I don't love seeing an increase in the total number of bull permits this year simply due to snow, but I do think the bulls survived this winter better than the cows and especially the calves statewide. I would recommend that the Wildlife Board not permit ANY cow elk hunts in 2023.

I hunt a lot of deep, dark timber where even at noon it's difficult to see the pins as the fiber optic doesn't receive enough sunlight. I feel like being sure of your pin is a necessity for ethical shots and helps to not pick the wrong one. Choosing one pin off could leave animals wounded and unrecoverable. The light I am speaking of does not project or aid in the take but merely takes the place of natural sunlight that is gathered by the sight. Still is physical sight pins and a manual movement by hand on "slider" sights. The light is powered by a standard watch battery and only projects directly onto the fiber that runs into the sight housing creating the physical aiming point inside.

I do appreciate your work and though we disagree on some points, I can usually understand your different viewpoints.

Maybe I am reading this one wrong or it just hasn't been considered.
