That leads to my next comment on how is it you can get an accurate count on deer numbers and buck to doe ratio when you count them during the rut when the deer are traveling to winter grounds and a lot of those deer move to different units so potentially you are counting deer on a specific unit that could summer on a completely different unit, you can't get accurate numbers that way it just doesn't work. I really wish the public would be listened to when it comes to permits and the health of the deer heard we are out in huge numbers seeing what it looks like on a daily basis and it doesn't matter what we think or see it's just what you think your data says is what it is but it's not at all accurate and the harvest of bucks does contribute to the health of the deer population, you kill 30,000 and that number is generous for how bad the success rates are deer in the state that is a pretty big hit if we are below objective on the minimum number of deer we want (400,000+) when it's well below that number anyway. I had a rifle deer tag last year on the fishlake the numbers that your data show do not add up I hunted the whole hunt from morning to dark covering basically the whole u it trying to find something to shoot, I did pass on a couple of younger bucks early in the hunt which turns out was a huge mistake because after the 3rd or 4th day I couldn't find a buck to shoot if my life depended on it, it came down to last light I finally found a 2 year old buck to shoot, all in all the buck numbers are not even close to what you say they are, they might be when you count them during the rut when deer all congregate from 2 different units but when they split and head back to the summer range the counts are way off.

Have you ever ran test unit scenarios of similar units carrying higher buck/doe ratios vs lower buck/doe ratios? There are so many monkey wrenches thrown into managing different units, to come to that conclusion as fact is misleading at best. This would definitely support your numbers increase for the southern part of the state for sure though. Why aren't you increasing tags on the Kamas and Thousand Lake? Both of those units are way over objective and you are decreasing tags??? Don't you want to see those herds flourish with lower buck/doe ratios??

Also, coming off the heels of one of our lowest harvest totals you are planning on increasing permits? On top of that you have decreasing fawn and doe survival and you are ramping up tag numbers?

I honestly don't care how many buck tags you are issuing, at this point make them unlimited. According to the division we will have a healthier deer herd if we get rid of excess bucks anyways...

If these recommendations are data driven the division seriously needs to find some different data sets like maybe observation and communication with local sportsman, land owners, ranchers, etc. Have you ever thought that maybe the division is collecting/interpreting data wrong and you do not have the animals you think you have? Maybe the division does not know how to grow deer? Sounds like the only thing that grows deer is mother nature according to the reason for population increases and decreases.

At the end of the day I have watched deer in my lifetime drop drastically over the last 30 years. If the objective for the southern region general deer is 103,000 (give or take) and by the divisions numbers we are currently at 81,000 (give or take) you have one of two problems. Either your carrying capacity/population objective is 20-40% below what it should be or your model you are using to get an estimated population is broke, kind of like your permit calculator. I am fully aware that we need does to build the deer population as well as to maintain the deer population. So, the one thing I am pleased to see is that you are not recommending increases in doe harvest (even though I'm sure your permit calculator calls for it).

The reason the division gets so much flack for increasing permits is because we still have enough people around that can remember how many deer used to be on the landscape. So when we are told that we can afford to harvest more bucks from the population, most of us that can remember when deer numbers were at carrying capacity call BS! Its like looking up at blue sky and telling us its yellow, and we have to look harder to see it. I guess eventually us "old timers" will stop giving a crap and quit caring, and you can pass off low deer numbers as high or adequate deer numbers.

The Beaver unit is once again way under objective in deer numbers, yet a +600 increase in tags is recommended for this unit like many other units in southern Utah. I have looked in most wintering areas on the Beaver unit, and for the life of me cannot see where deer numbers have increased like the tag numbers reflect. With very low and concerning deer numbers on the Beaver unit as currently exists, it is very hard to find any reason to add 600 tags to this unit. At this time there is just not enough total number of deer to justify such a large increase in Buck tags.

I am thankful for the RAC process and would hope that you would carefully look at the increase in tags in all of our southern units. I do not feel that the southern unit needs to be a pawn in making up for lost tags in Northern Utah. The sportsmen of Southern Utah drive out and look at deer every year in the deer wintering grounds. I would ask you to ask these sportsmen if they are seeing these large increase in our deer herds rather than trust the output of a calculator or gamble on what the weather will do each year.

The fact is the Deer Numbers are down, yes even in Southern Utah. Because I am most familiar with the Beaver unit, I can honestly say that this unit is in no position to add General season buck tags of 33%, where deer survival in general is struggling to increase on this unit.

My comments are based on my experience hunting the Zion unit exclusively for the past 12 years, so I will say that I don't know what may or may not be going on with deer herds on other units with proposed tag increases.

I recognize that deer management is a complex and dynamic undertaking and there is a need to use models to supplement what can be observed on the ground. I understand as well that I will probably not see the same amount of bucks during a hunt as I would doing winter deer counts, due to migration from other units (Panguitch, Paunsaugant) or out of Zion National Park and the large amounts of private property on the northwest corner of the unit. But I do not feel that there are enough bucks on the unit to support another 1,100 tags.

The last two seasons I have spent most of my time hunting with new hunters that are mostly just looking to have an opportunity to harvest a legal buck. It has been difficult to get these hunters that opportunity as there just are not the bucks on the landscape as there were pre draught. I know that these general season units are not meant as trophy units, but it is discouraging to not even have opportunities at younger bucks. If tag numbers are held low for a few more years it would give the herd a chance to continue to rebound and create a much more enjoyable hunt with more opportunity.

I also understand that there is a need to generate revenue to manage our herds. I don't want to think that these proposed tag increases are to make up for the winter kill of last winter on a few of the northern units, but if it is, maybe it's time to consider increasing tag prices instead of tag numbers. Or possibly offering hunters the opportunity to purchase another "conservation tag" which would be nothing more than a \$45 donation, but takes the place of one of the proposed increase tags.

I appreciate the opportunity to provide comments on the southern general season deer permit recommendations.

I feel my comments are a broken record, a rinse and repeat from my comments in 2023. I am again, surprised to see the dramatic proposed general season permit increases to many southern region units in some cases I'll outline below there are proposed to double in just the last two years (Pine Valley). I can only assume that the DWR feels that the yearling buck recruitment will be so incredible that they can justify increasing permits now, immediately after years of healthy tag cuts and years of drought. This is despite many units that they are recommending tag increases on being below the approved buck:doe objective or directly at objective. I find some blaring inconsistencies in units I'd like to illustrate. I might emphasize that we hear all the time from the UDWR that we manage according to the management plan in place and approved by the RAC/ Board process, not to speculation or gut feel. I strongly feel that a slight upward trend in fawn production does not yet warrant the level of increases that are proposed. I believe the UDWR is simply moving too fast and trying to re-claim lost tags/opportunity at the expense of only the Southern Region, where we have big public land units where they feel they can cram more hunters into. We should not be looking at one better fawn/yearling recruitment year and possibly a second year in 2024, as a monumental trend, or basis for "feeling" that in 2024 units will see increasing post-season buck:doe ratios in November 2024. We manage to the plan, and the plan says we manage for a 3 year average buck: doe ratio of 15-17 or 18-20 bucks per 100 does on all general season units. Furthermore, the presentation by the BYU professor indicating that buck numbers in excess of 6-10 per 100 does in Utah and around the West have been, or are a limiting factor in Mule deer population growth, is laughable and insults the intelligence of many Utah hunters, and all hunters around the West. We are so far from being at population objectives or carrying capacity on most of deer herds that the notion of "bucks stealing forage from does/fawns resulting in lower productivity", and thus we should kill more bucks to "stimulate" our herds, is so far off from our real problems with our deer herds, that it's scary to hear such a touted claim by someone in authority.

Here are some things I have concerns with the UDWR proposals.

Last fall the UDWR presented many units in southern Utah have weapon restrictions of single strand bows, primitive muzzleloaders, and no scopes on centerfire rifle on a handful of units in an attempt to reduce harvest, but increase opportunity. This would lead one to believe that the UDWR realizes they can just pour the tags into units recovering, or on the verge of recovering after drought. However, now, in a most conflicting manner, the UDWR is proposing incredible tag increases on these very same units with no restrictions to method/weapon of take. What changed?? No consistency here. Do we need to limit buck harvest or have an overabundance of bucks?? Stark conflicting proposals form the UDWR in just a short 5-6 months time!

- 1. The Beaver unit shows an average buck:doe ratio over the past 3 years at 17.5 bucks:100 does. This unit is not in compliance with the current 18-20 bucks/100 does in the plan and only 1 individual year within the last 3 was over 18/100. So it should NOT be a candidate for permit increases, however the UDWR is recommending a huge 600 permit increase from 1,200 to 1800 for 2024. How is this justified?? I believe the Beaver unit should see a no change for permit numbers for 2024.
- 2. The Pine Valley Unit 3 year average buck:doe ratio is sitting at 19.4 bucks per 100 does, which is directly in the middle to slightly above the acceptable range in the approved plan of 18-20 bucks per 100 does. Yet an enormous 1,100 permit increase is recommended from 2,300 to 3,400? This is after a 600 permit increase in 2023. The permit numbers from 2022 were at 1,700 to the 2024 proposed number of 3,400 is a DOUBLING! This proposal is without the buck numbers or buck/doe ratios showing a doubling or even significant increase, again the current 3 year average sits at 19.4 remember? How is this justified?? One can only conclude that the UDWR is anticipating a good yearling buck crop next fall and so the recommended permit increase is justified. But an anticipated yearling buck recruitment, is not a metric the plan calls for when setting permit recommendations. I believe we should leave the Pine Valley with no permit change, or a slight increase for 2024. And I believe the population model for total deer numbers and thus total adult doe numbers are grossly over estimated which results in a gross over estimation of the number of buck fawns entering the population as yearlings in 2024. I believe the over estimation (modeled population) of overall deer population numbers is the cause of so many of these extreme permit recommendations in the southern region. Overestimating the total population of a deer herd, and therefore the number of adult does, repeatedly over and over each year can result in inflated numbers of fawns, and bucks "supposedly" entering a population. There is no solid ground truthing mechanisms to verify deer populations on our units like we have when we aerial survey elk, antelope, bighorn sheep, etc every 2-3 years, to validate or refute population models and tweak them. Deer population estimates used in models were "best guesses" and I've contended for years are far too high. This is a big factor when then putting too much stock into a big yearling buck cohort the model says you have coming. You can't with any degree of certainty say there are X number of yearling bucks coming into a population this year and set tags accordingly, when you don't really know closely the number of adult does you have on a unit. A best guess with deer is all we have, and a best guess that is even 10-15% off, over 10-20 years can cause population estimates to drift far from reality. I give this feedback from the perspective as a former UDWR biologist myself, knowing the intricacies and difficulties of estimating deer populations. It is not an easy task, but I feel. like many southern Utah sportsmen do as well, that our experience and time spent across most units in southern Utah, that there are no where near the total number of deer present that current UDWR populations estimate them at.

To further illustrate the inconsistency among big public land southern Utah units lets look at another unit.

To use the San Juan Abajo unit as an example The San Juan Abajo unit shows an average buck:doe ratio over the past 3 years at 20 bucks:100 does both in 2023 and 2024. As you can see, this unit is in compliance and at, or even slightly over objective. It is in compliance with the approved management plan of 18-20 bucks:100 does postseason, and could even be justified for a permit increased. But even with a 3 year buck:doe ratio of 20.9 in 2022, and 20.0 in 2023, the UDWR is has and is NOT recommending any permit increases, and it recommended to leave as status quo again for 2024. How is this justified?? The Central Mtns Manti unit 3 year buck:doe ratio currently sits at 20.3 bucks/100 does with individual years of 20.1, 22.0, and 18.9 bucks:100 does, but is only seeing a proposed permit increase from 7,800- 8,000 tags. Why so little for a huge public land unit that is over objective?

Why is the southeastern region units not targeted for permit increases like the Southern units? I have my theories, but I'd like to hear the UDWR explain it. If we manage all public land general units the same, then why have we not seen increases to the San Juan Abajo Lasal Mtns, Or Central Mtns Manti at all, or near the extent we do in the southern region?? Very inconsistent, again reason to point out the Southern region is always asked to bear the brunt of public land permit increases. Always!

There is no consistency in following the approved plans when comparing one unit vs another. Why?

The UDWR seems too eager to increase tags in the southern region with just one, and possibly a 2nd year of positive precipitation and fawn recruitment, but not actual population or buck numbers dramatically increasing yet.

I highly suggest that the southern RAC consider the data presented against the approved UDWR management plans that are IN PLACE, and do not increase permits, or to the extent proposed by the UDWR where there is not a basis for doing so.
