First is that using iron sights leads to more wounded and unrecovered animals as hunters will be pressured to make more difficult shots in order to fill their tag. Although this may decrease the number of deer harvested overall, having more wounded and unrecovered deer is not something that we want. Consider as well that Utah law allows for hunters to keep hunting if an animal is unrecovered. This can lead to more deer deaths that you are able to measure, an potentially more that would occur without the restriction. The second point to consider is that many hunters do not own hunting rifles with iron sights. This means that in order to hunt on these units, hunters who do not own iron sighted rifles will be forced into buying such rifles which has the potential to put a serious financial strain on many. I worry about the elk herd as it is in the Uinta Basin. I have hunted that unit consistently for the past 10 years. Elk numbers have never in my opinion been lower than what they were this year. There has been a slow decline over the years of elk numbers. If you want the elk to be off of private land maybe you should stop flying the helicopter over the forest and dropping "poppers" down on to forest and breaking up the elk herds and pushing them down towards the Indian land which is right next to a majority of private lands. If it's not the DWR doing this, then something should be done about whoever is doing it. I was very dissatisfied with my elk hunt this year. Would be nice to see more than 11 elk over a weeks time. I put in over 30 miles on foot that week. In regards to the antler point restriction, I hunted Pine valley this year general deer Muzzleloader. I have to say I was very dissatisfied with the quality of deer on the unit. But adding further restrictions on an already restricted hunt (the deer hunt) is a terrible idea. If I had waited the three years to draw like I did this year and was not able to fill my tag because I did not see a 4 point in Pine valley I would be upset. I did not see a deer with more than 3 points on one side during my time hunting. I hunted every single day, and scouted a month in advance. Also how am I supposed to get my own children interested in hunting if I am not able to hunt a deer and harvest one with my children there? Restricting pine valley will also limit the hunting units available to us in Southern utah as well. Unlike northern utah we in southern utah have easy access to 2 units Zion and Pine valley. Also strongly disagree with the statement that it is taking 1-3 years to draw a deer tag. I have consistently been at the three year mark to draw a tag. Also my mother had to wait 4 years and same for my father to draw a tag. These numbers are ridiculous. How are we supposed to interest our children in hunting as well as hunt in the state of utah when you realistically look at it with the draw the way it is my own mother will only hunt a deer maybe 5-7 more times in her lifetime?

I have been been in the Dedicated Hunter program since its inception. I have hunted the same area in the Cache Unit for over 46 years. I have been extremely satisfied with deer hunting. Last year hunters were required to pull magnifying scopes off of muzzleloaders. This change cost \$500 for a new sight system. Under this new proposal I will have to scrap my current muzzleloader and invest \$500 to \$600 for a muzzleloader that fits the restricted muzzleloader definition.

We will also be required to remove our scopes off our rifles. "If only our rifles had iron sights", so back to the store to purchase a rifle with iron sights. Another six to nine hundred dollars. This research study could cost each hunter a minimum of \$1,200 if they are in the Dedicated Hunter program or \$500 to \$900 if they draw muzzleloader or rifle tag.

The Cache unit currently has around 200 Dedicated Hunters. Each hunter completes 32 hours or they buy their hours at \$40 per hour. If half of the dedicated hunters drop out due to the new equipment requirements, it could be a loss of 3,200 volunteer hours. Will other sportsman's organizations step up to complete the volunteer hours? Will habitat projects on the Cache unit not be completed?

What is the purpose of this proposal? Is it to increase the number of licenses sales or is it to increase the number of bucks?

The Cache unit currently has 17 bucks per 100 doe's post season. Objective is 15 to17 bucks per 100 doe's post season. The Cache unit is very weather dependent. When we have a hard winter we lose our deer. If we have more bucks than objective, it takes longer for the deer herds to rebound from winter loss. The bucks out-compete the doe's for survival, reducing the reproduction and survival of fawns.

Next year I will be 62 and my eyesight is declining. I depend on a scope to insure I make a humane harvest. Open sights including a peep sight with a globe front sight has made precision shot almost guess work. I can't imagine a new hunter using open sights when the hunter education course allows them to use scopes to pass their shooting proficiency test.

Lets wait until the data is collected from this years hunt before significant changes are made impacting the 4,000 plus hunters that hunt the Cache unit.

This proposal doesn't do anything for habitat that will sustain deer numbers.

Dear Utah Division of Wildlife Resources,

I am writing to express my concerns regarding the new proposal, particularly with the Cache unit, and to register my opposition to any further weapon restrictions related to rifles. Implementing such restrictions is not the solution to improving the health of deer units. Instead, a point restriction on bucks, similar to the proposal for the Pine Valley unit, would be a more effective approach.

Removing optics from rifles will not benefit hunters or deer populations. In fact, it may result in more wounded animals that cannot be recovered, leading to unnecessary suffering. We cannot afford to discover years down the road that these restrictions were a mistake. It began with the restrictions on trail cameras, followed by changes to muzzleloader regulations, and now rifles are being targeted. I strongly urge you to vote against further restrictions.

I appreciate what the division is trying to do by increasing hunter opportunity by decreasing the effectiveness of the weapons that are allowed on each hunt. However, a rifle season restriction of "open sights only" is just insanity. When was the last time anyone in the division walked into a gun store? There's likely not enough open sight rifles on the shelves in the entire state of UT to allow everyone with a Cache tag to hunt. It puts 99% of hunters in an economic bind as they will now have to purchase a new weapon to hunt the general season.

If you want to limit "effective" range, please consider eliminating the use of laser range finders instead. The LRF is without a doubt the tool that has allowed effective ranges to be pushed beyond limits ever thought possible 25 years ago. Without an accurate range, long range hunting becomes a moot point. It returns hunters back to the time when they "held 4 feet over it's back and prayed". The likelihood of successful shots beyond 400 yards goes to almost zero without a LRF, especially for the "average" hunter.

I know that patrolling LRF use in the field would be difficult, but make the penalty for breaking the law extremely harsh and people will comply. Just like the trail camera changes that were recently implemented, not everyone follows them, but the vast majority have.

I have similar thoughts on muzzleloader hunts. The division allowed technology into that season and let it grow in popularity. Many people purchased weapons to go hunt that season, and now their weapons will be "useless" to them. If the board decides to send the Cache back to primitive muzzleloading, I hope they consider moving the season back to November like it was in the old days.

One last thought, I'm all for "open sight" only tags to increase opportunity, but a certain number of normal tags should still be given each year to allow people to hunt with the weapons they already have. Possibly doing a limited number of tags on an early season for "normal" weapons and then a bigger number of tags for the open sight season at a later date (or vise/versa) would be a good compromise.

But in reality until this year how could we possibly expect that data to be correct.

So because of someone's idea, we are going to seriously impact thousands of sportsmen, many of them kids with this new restriction. Just to see if it has positive affects.

I have 2 new hunters in my family. One that will turn 12 this year, and another that has had 2 hunting seasons. With your proposal, both of these young men will have their whole youth hunting season taken from them. We could move to open sights, but this would take a huge investment of both time and money. Many of these youth are limited on time. And further handicapping them with these limitations will make it even harder for parents to get them out in the field. So something that was loved and looked forward to will be turned into frustration. This will also severely impact our older generation that rely heavily on optics to continue their love for hunting.

On the weapon restrictions, for the muzzleloader, this essentially just takes us back to what it used to be only 15 or so years ago before the inline muzzleloaders became popular.

For the any weapon hunts, there will be a lot of comments saying that this will only increase the wounding loss, and I say two things to that... #1: That's part of what we want to measure, and #2: If it increases the wounding loss, that fault is on the hunter, not the weapon. Wounding loss wouldn't increase if the hunters made sure they only took shots that are well within their personal skill set. This argument is true regardless of the weapon type, and is simply a smoke-and-mirrors argument made because people don't want to change their weapon.

For the Thousand Lakes portion of this proposal, I'm personally excited for the opportunity to burn my deer points to have the chance at a LE hunt with my longbow. (in a place where only other restricted archers are participating), and I hope this brings more hunters over to the "traditional" archery side. It's a small group in the state currently, but this opportunity might bring more archers to give it a try, and they'll quickly learn that shooting a "stick and string" is a lot more fun.

I hunt Cache unit exclusively, I am supportive of antler restrictions and tighter tag numbers for rifle hunts. The research is not provided in the presentation. More information to inform this strategy needs to be presented that this would be effective. The DWR will need to demonstrate with statistics from other states or with data from previous changes in other units in 2023. The proposal seeks to address hunter perception and deer management which these strategies are contradicting. Making it impossible to achieve both objectives. This is an expensive solution to the hunter and increases the profits of price gougers selling equipment. There are hardly any modern rifles in common calibers that are equipped with open sights or peep sights. Given the governments anti-gun position and the firearm industry bottle neck on both arms and ammunition, many people will not be able to acquire a new firearm prior to the season. Ammunition will be the most limiting followed by access to a rifle that meets the requirements. This is a step backwards in effective take and will likely result in wounded animals. A moderate approach would be to limit the power of the rifle scope to 3x. With the current proposed changes, people with visual impairments will be excluded unless exemptions are allowed. Using a percussion cap or flint lock is dangerous to the hunter and the animal. Misfires and the delay burn will result in wounded animals. The 209 primer is a much safer and ethical mechanism for muzzleloaders. A moderate approach would be to restrict the powder form to loose powder only instead of pellets. I support the 1x current rule for muzzleloaders. I do not support the restrictive definition noted in the proposal concerning muzzleloaders.

If you take away scopes or limit magnification on a rifle all it does is wound more animals. Will these weapons restrictions apply to CMWU units that are located within these units. What about outfitters that have clients that are booked years in advance for any weapon hunts in these units. Will they be limited to restricted weapons? Looking at the data in the presentations, weather, habitat and predators seem to have the biggest impact on deer herds. Not the hunters. People are always complaining that there are no big deer to hunt. I disagree with that mind set. There are big deer to hunt, but it takes time, effort and patience to find them. They are adapting to the environment around them. They go to places where there is less pressure. Those places most often are hard to get to and take effort and time. Over the last several years, I seen more mature deer than I ever have previously, but I have also had to change the way I hunt. Let's focus on the key factors that we can help manage such habitat, predator control, fencing to have less deer killed by automobiles and things of that nature. Restriction on weapons will require a major portion of the hunting population to have to purchase new weapons that will meet the weapons restrictions. For some people it's not an issue, but for others it's a significant investment. Go to a local sporting goods store and see how many rifles you can find that have open sites. Last time a looked there were very few. I hope that the public comments that are submitted for these changes are really taken into consideration. There is very strong sentiment amongst the majority of hunters that their comments and feedback are being pretty much ignored by those making the decisions based on changes that have been made the several years. Do you have any comments about the proposed management plan?

I believe there needs to be a change in the way mule deer are hunted, especially in the northern region around Cache County. I've hunted this area for over a decade, and the drop in deer numbers has been hard to ignore. When I was a kid, it wasn't unusual to see 30 deer in a group, with a few good bucks mixed in. This year, though, I spent three days backpacking and covered about 40 miles on horseback, and I only saw one mature buck. That's just not normal.

Because of this decline, I strongly support efforts focused on predator control, access management, winter feeding, and restricting firearms to open sights for five years.

From what I've seen, mountain lions are having a big impact on deer numbers. Every time I've gone out this season-which is at least 25 times-I've either seen a mountain lion or come across their tracks. I've spotted them in Logan Canyon, around Mount Logan, and near Mount Elmer. In the winter, I've even seen them following deer herds. So, when people say there aren't many mountain lions out there, I know that's not true. The recent change in the law that allows hunting them with combination permits might help, but I still don't think it's enough to protect deer and elk populations. We need more efforts on both sides-effective predator control and responsible hunting practices.

I also think access management plays a major role in protecting wildlife. For example, behind the Hardware Ranch area, most roads are open until hunting season starts, and then they're closed. That limits access to people on horseback or on foot, and it's made a noticeable difference-though not a huge one-in the deer and elk numbers. I don't believe all roads need to be closed, but shutting down key roads that cut through deer habitat during hunting season makes sense to me.

Winter feeding is more complicated. On the one hand, feeding deer during the winter helps them survive and grow stronger. But it also creates issues by drawing predators to a concentrated area and increasing pressure from shed hunters. If winter feeding is expanded, I think it's important to have clear rules in place to deal with these problems, including managing predators and regulating shed hunting. If that can be done, I think increasing winter feeding would benefit both deer and elk herds.

I'm also in favor of limiting firearms to open sights or low-power scopes for five years. There's proof that this approach works. The North Cache Unit, where the only tag available is the HAMS tag, is a great example. Since implementing that tag, the elk population has bounced back, and now it's common to see impressive bulls in the area. I believe the same approach could work just as well for mule deer in the Cache Unit.

I think another issue that needs to be addressed is archery hunting. In my experience, I've never seen an archery hunter drop a deer on the spot. Even with a good shot, the deer usually runs several hundred yards before

it finally beds down and dies. More often than not, though, the shot isn't great, and the deer ends up running much farther, dying without ever being recovered. This allows hunters to wound multiple animals over a season. I'd be curious to see how many deer are wounded and never recovered during archery season compared to muzzleloader season. I'd bet the numbers show more unclaimed animals during archery season. If that's the case, I think archery tags should be reduced, and those tags should be reallocated to youth hunters using muzzleloaders or open-sight firearms for the next five years.

Overall, I think these changes-predator control, better access management, thoughtful winter feeding, and restricting firearms to open sights-would go a long way toward rebuilding the mule deer population. If we can also address the issues with archery hunting, I believe we'd see healthier deer and elk herds in the future.

One unit in general and one in limited entry would be ideal.

My name is Michael Arnette, Nonresident so take that as you will. I'm a die hard Traditional bow hunter, have been for a couple decades. I'd like to take a minute to voice my opinion on the need for small traditional archery opportunities aside from compound bowhunting, specifically for mule deer. One great example this is the trout creek area in Oregon, where traditional archery is required. Another is the Mcalester Army Ammunition plant in Oklahoma. Both allow for significant numbers of Bowhunters to enjoy great draw odds due to the limited equipment.

With a traditional bow my ethical range is within 25 yards. I can shoot out to 30 yards but am not able to hold an ethical group on deer sized animals. For most the traditional bow is ethical 20 yards and in. This severely limited range makes it the perfect tool for maximum tag opportunity.

I've been following this issue for awhile and last year when the department at the last minute dropped the primitive archery restrictions in your plan I was very disappointed. I understand the reasoning was youth being restricted. I believe this could be an easy fix by allowing youth to use compound bows. Similar to the antler restrictions in Pine Valley. When I read the news I went out and bought a compound (I haven't shot one since 2005) and within 3 weeks was able to hold softball sized groups at 60 yards and have a max ethical range of 70 yards. This is not uncommon as you well know and nowadays you rarely hear of an archery mule deer taken below 50 yards.

Hunting with a recurve, I've been within 50 yards of countless mule deer I wanted to shoot on every single hunt, in most cases several times. But the difference between a 50 yard effectiveness and a 25 yard effectiveness is massive when it comes to mule deer. They are one of the few animals that has adapted to a singular predator; the mountain lion by being incredibly adept at evading danger within a 50-60 yard distance. However this came at a cost and when they are able to be taken at further distances they become extremely susceptible to harvest.

It's time to separate a very small portion of tags between modern and traditional archery. We don't need much, after all we represent less than 5 percent of Bowhunters.

I ask for one unit, two would be even better. Give us a chance to show the benefits our limited equipment can provide.

One more consideration, a draw blood=punch tag rule for this equipment. Hard to enforce but easy to follow for the majority and will make a push towards ethical shots. The traditional archery community is one of the few who would wholeheartedly accept this.

The buck to doe ratio in the kamas unit is not a true factual representation of what's present on the landscape and definitely not available to public hunters. Based on my findings its 6 bucks to 100 does and the deer population is not correct either. We need to continue changing hunts from the standard ways of the past. Removing scopes from muzzleloader and RIFLEs would be highly recommended and needed.

Keeping high pressure off bigger bucks and making it fair chase again. All my kids learned to shoot iron sights. And are just as equipped too shoot a deer with iron sights as with a scope.

Do you have any comments about the research project?

I am tired of, and generally opposed to the constant rule changes.

I oppose the changes to make muzzleloader restrictions different from one unit to the next in the same state. It will lead to further confusion. I was opposed to the rule change in 2024 to remove high power scopes from muzzleloaders. I don't believe hunters became more ethical simply due to a rule change. Regardless of technology advancements with inline muzzleloaders, muzzleloaders remain single-shot, limited range weapons regardless of whether they have a scope. Having a scope simply makes the shots taken more likely to be lethal sooner, rather than resulting in an unrecovered animal.

I oppose the proposed changes to enforce sidelock muzzleloaders in certain units and believe that it will only lead to more wounded/unrecovered deer.

It seems very clear to me that selling more tags and creating rule changes designed to decrease harvest rates can only serve to decrease hunter satisfaction, not increase it.

If herd numbers are too low in certain units, I suggest you decrease permits or make even smaller units.

If decreased permit sales are a necessity due to herd sizes, and this means less hunting opportunities, I believe most hunters would prefer to have fewer opportunities in favor of better opportunities. More hunting opportunities just means hunters see more orange in the field when they do hunt. If revenue is the issue, I suggest you raise fees. Start with out of state tag fees. Fee rates have not come close to keeping up with inflation year over year. Virtually nobody in Utah hunts solely for the "food."

Please, don't change the muzzleloader rules for certain units. Don't change the muzzleloader rules to be more restrictive anywhere.
