> Time after time I have been to these meetings and heard the strongest factor in increasing or decreasing the deer herd is weather related. When weather is good, habitat is good and deer increase. When weather is dry and hot the opposite happens and deer decrease.

> So as we look at this past winter we see that this year southern Utah has not had any significant moisture, which according to your statements every year should mean deer numbers will decrease. Remember your statement of shoot them while the weather window is good, otherwise they just die due to weather.

> Well here we are in a down weather year and we are raising the tags in the Beaver units by over 50%. Looks like to me that we shoot them when the weather is good and then lower the buck/doe ratio and shoot even more when weather has a down vear.
